Chairman's Statement

主席報告

Dear Shareholders,

On behalf of the board of directors (the “**Board**”) of Prime Intelligence Solutions Group Limited (the “**Company**”), I hereby present the annual report of the Company and its subsidiaries (together the “**Group**”) for the year ended 31 March 2026 (the “**Reporting Period**”).

LISTING

On 14 February 2018, the Company was successfully listed (the “**Listing**”) on GEM of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”). The Listing has laid a foundation for the Group’s continuous development.

BUSINESS REVIEW

The Group is a provider of biometrics identification solutions in Hong Kong (“**Hong Kong**”) Special Administrative Region of the People’s Republic of China (“**PRC**” or “**China**”) and the PRC. The Group markets itself using the brand “**Solution Expert**”. The Group markets its products through the sales of products which include biometrics identification devices and other devices and accessories, and provision of auxiliary and other services. The Group’s biometrics identification devices have one or more of the following functions: face identification; fingerprint identification; finger vein identification; hand geometry identification; and iris identification.

The Group would like to share more details of its performance, financial position and other information for the year ended 31 March 2026 with shareholders (“**Shareholders**”) in the following section headed “Management Discussion and Analysis”.

PROSPECTS

Apart from its commitment to the development of its principal business, the Group will actively make progress to generate growth and strive for potential and new business opportunities. The Group plans to further its growth in existing business by strengthening its marketing capabilities and expanding its product portfolio through enhancing software development, with a view to further enlarging its market share in Hong Kong and Macau and becoming one of the active biometrics identification solutions providers in the PRC. As such, the Group has utilised the net proceeds from the Listing on (i) enhancing the quality of after-sales and strengthening the operation support as part of the expansion plan of the business in the Southern China; (ii) improving its information technology system; (iii) setting up a new and separate software development centre in the PRC to further enhance and develop the Group’s software; and (iv) research and development on touchless biometrics identification devices and Artificial Intelligence & Internet of Things (“**AIoT**”).

上市

於2018年2月14日，本公司於香港聯合交易所有限公司（「**聯交所**」）GEM成功上市（「**上市**」）。上市為本集團的持續發展奠定基礎。

業務回顧

本集團為中華人民共和國（「**中國**」）香港（「**香港**」）特別行政區及中國的生物特徵識別解決方案供應商。本集團以品牌「**Solution Expert**」為自己進行營銷。本集團透過銷售生物特徵識別裝置、其他裝置及配件等產品以及提供配套及其他服務營銷產品。本集團的生物特徵識別裝置有一個或多個以下功能：人臉識別；指紋識別；指靜脈識別；掌形識別；及虹膜識別。

本集團將於下文「管理層討論及分析」一節，與股東（「**股東**」）分享更多有關本集團截至2026年3月31日止年度的業績、財務狀況及其他資料詳情。

前景

本集團除致力發展其主要業務外，亦積極尋求增長及努力發掘潛在新商機。本集團計劃透過加強營銷能力及加強軟件開發擴大產品組合，進一步為現有業務帶來增長，從而進一步擴大於香港及澳門的市場佔有率及成為活躍的中國生物特徵識別解決方案供應商之一。因此，本集團已動用通過上市所得款項淨額，以(i)提高售後服務的質素及加強營運支援，作為拓展華南地區業務的一部分；(ii)改進其資訊科技系統；(iii)於中國設立一個新的獨立軟件開發中心以進一步提升及開發本集團的軟件；及(iv)研發非接觸式生物特徵識別裝置以及人工智能及物聯網（「**AIoT**」）。

OVERVIEW

The Group is a provider of biometrics identification solutions in Hong Kong and the PRC. The Group derives revenue from the following business activities: (i) sales of biometrics identification devices, security products, and other accessories; and (ii) provision of auxiliary and other services. The Group's biometrics identification devices have one or more of the following functions: (i) face identification; (ii) fingerprint identification; (iii) finger vein identification; (iv) hand geometry identification; and (v) iris identification. The revenue of the Group for the year ended 31 March 2026 was approximately HK\$82.4 million, representing an increase by approximately 22.3% from approximately HK\$67.4 million for the year ended 31 March 2025. The increase in revenue was mainly attributable to (i) increase in sales from the provision of online information and digital marketing services by approximately HK\$15.1 million (or 2,658.5%) as compared with the corresponding period in 2025; and (ii) increase in revenue derived from the provision of auxiliary and other services by approximately HK\$13.7 million (or 56.4%) as compared with the corresponding period in 2025.

Revenue represents the invoiced values of goods sold and services rendered, after allowances for returns and discounts during the reporting periods.

概覽

本集團為香港及中國的生物特徵識別解決方案供應商。本集團透過以下業務活動產生收益：(i) 銷售生物特徵識別裝置、保安產品及其他配件；及(ii) 提供配套及其他服務。本集團的生物特徵識別裝置有一個或多個以下功能：(i) 人臉識別；(ii) 指紋識別；(iii) 指靜脈識別；(iv) 掌形識別；及(v) 虹膜識別。截至2026年3月31日止年度，本集團的收益約為82.4百萬港元，較截至2025年3月31日止年度約67.4百萬港元增加約22.3%。收益增加主要由於(i) 提供網上資訊及數碼營銷服務銷售較2025年同期增加約15.1百萬港元（或2,658.5%）；及(ii) 來自提供配套及其他服務的收益較2025年同期增加約13.7百萬港元（或56.4%）。

收益指所售商品及提供服務的發票值，於報告期間經扣除退貨及折扣。

Cost of Sales and Gross Profit

The majority of the Group's cost of sales and services rendered was costs of inventories sold. The Group's costs of inventories sold decreased by approximately 31.9% to approximately HK\$16.9 million for the year ended 31 March 2026 (2025: approximately HK\$24.8 million). The gross profit margin dropped from approximately 46.1% for the year ended 31 March 2025 to approximately 40.4% for the year ended 31 March 2026. The gross profit raised from approximately HK\$31.1 million for the year ended 31 March 2025 to approximately HK\$33.3 million for the year ended 31 March 2026. The increase in gross profit was mainly due to the increase in revenue.

Expenses

Staff costs for the year ended 31 March 2026 was approximately HK\$38.8 million (2025: approximately HK\$31.9 million), representing an increase of approximately HK\$6.9 million as compared with the last corresponding period, which was mainly due to the increase in number of employees and salary increment during the period.

Administrative expenses for the year ended 31 March 2026 were approximately HK\$38.3 million (2025: approximately HK\$23.5 million), representing an increase of approximately HK\$14.8 million as compared with the last corresponding period, which was mainly due to the increase in staff costs and impairment loss on right-of-use assets.

Taxes

The income tax expense comprised Hong Kong Profits Tax and PRC Enterprise Income Tax for the year. The income tax expense for the year ended 31 March 2026 was approximately HK\$0.8 million (2025: HK\$24,000).

Under the two-tiered Profits Tax Regime, one of the Company's Hong Kong subsidiaries is subject to Hong Kong Profits Tax at the rate of 8.25% for the year ended 31 March 2026 (2025: 8.25%) for the first HK\$2 million of its estimated assessable profits and at 16.5% for the year ended 31 March 2026 (2025: 16.5%) on its estimated assessable profits above HK\$2 million. Other Hong Kong subsidiaries not qualifying for the two-tiered Profit Tax Regime are subject to Hong Kong Profits Tax at the rate of 16.5% for the year ended 31 March 2026 (2025: 16.5%).

銷售成本及毛利

本集團大部分銷售及已提供服務成本為已售存貨成本。截至2026年3月31日止年度，本集團的已售存貨成本減少約31.9%至約16.9百萬港元(2025年：約24.8百萬港元)。毛利率由截至2025年3月31日止年度約46.1%下跌至截至2026年3月31日止年度約40.4%。毛利由截至2025年3月31日止年度約31.1百萬港元增加至截至2026年3月31日止年度約33.3百萬港元。毛利增加主要是由於收益增加。

開支

截至2026年3月31日止年度，員工成本約為38.8百萬港元(2025年：約31.9百萬港元)，較去年同期增加約6.9百萬港元，主要由於期內僱員人數增加及薪金調升所致。

截至2026年3月31日止年度，行政開支約為38.3百萬港元(2025年：約23.5百萬港元)，較去年同期增加約14.8百萬港元，主要由於員工成本增加及使用權資產減值虧損所致。

稅項

所得稅開支包括年內香港利得稅及中國企業所得稅。截至2026年3月31日止年度，所得稅開支約為0.8百萬港元(2025年：24,000港元)。

根據兩級制利得稅率制度，本公司其中一間香港附屬公司須就其截至2026年3月31日止年度估計應課稅溢利的首2百萬港元按8.25%(2025年：8.25%)的稅率繳納香港利得稅，並就其截至2026年3月31日止年度超過2百萬港元的估計應課稅溢利按16.5%(2025年：16.5%)的稅率繳納香港利得稅。其他不符合兩級制利得稅率制度的香港附屬公司須於截至2026年3月31日止年度按16.5%的稅率繳納香港利得稅(2025年：16.5%)。

The Group's subsidiary established and operated in the PRC is subject to PRC Enterprise Income Tax at the rate of 25% for the year ended 31 March 2026 (2025: 25%). Approximately HK\$0.8 million of PRC Enterprise Income Tax has been provided for the year ended 31 March 2026 (2025: HK\$24,000).

Loss for the Year

The Group incurred a net loss of approximately HK\$15.5 million for the year ended 31 March 2026, as compared with a net profit of approximately HK\$1.6 million for the year ended 31 March 2025. The increase in the net loss was mainly due to (i) an increase in administrative expenses mainly from the increase in operating lease charges in respect of premises under short-term lease arrangements and increase in impairment loss on right-of-use assets and increase in staff costs (ii) an increase in interest expenses on promissory notes.

Liquidity, Financial Resources and Capital Structure

Historically, the Group has funded the liquidity and capital requirements primarily through operating cash flows, bank borrowings and proceeds from Listing. The Directors believe that with the new capital from Listing, the Group is in a healthy financial position to expand its core business and to achieve its business objectives. As at 31 March 2026, the Group issued 18 tranches of promissory notes with the aggregate principal amounts of approximately HK\$7.2 million. The interest for the promissory notes is charged at 5% per annum (31 March 2025: the Group issued 6 tranches of promissory notes with the aggregate principal amounts of approximately HK\$1.9 million. The interest for the promissory notes is charged at 5% per annum). The Group requires cash primarily for working capital needs. As at 31 March 2026, the Group had approximately HK\$17.7 million in bank and cash balances (31 March 2025: approximately HK\$4.2 million).

Gearing Ratio

At as 31 March 2026, the gearing ratio was 306.9% (31 March 2025: 21.1%). Gearing ratio is calculated by dividing total debt by total equity as at the respective period end. For the avoidance of doubt, total debt includes promissory notes and lease liabilities.

本集團於中國成立及營運的附屬公司於截至2026年3月31日止年度須按25% (2025年：25%) 的稅率繳納中國企業所得稅。截至2026年3月31日止年度，中國企業所得稅約0.8百萬港元已作出撥備 (2025年：24,000港元)。

年內虧損

截至2026年3月31日止年度，本集團產生淨虧損約15.5百萬港元，而截至2025年3月31日止年度則為淨溢利約1.6百萬港元。淨虧損增加主要由於(i)行政開支增加，主要由於短期租賃安排項下物業的經營租賃費用增加、使用權資產減值虧損增加及員工成本增加；及(ii)承兌票據利息開支增加。

流動資金、財務資源及資本結構

過往，本集團主要以經營現金流量、銀行借款及上市所得款項為流動資金及資本需求提供資金。董事相信，由於上市而獲得資金，故本集團的財務狀況穩健，足以擴充其核心業務及達致其業務目標。於2026年3月31日，本集團已發行十八批本金總額約為7.2百萬港元的承兌票據。承兌票據的年利率為5% (2025年3月31日：本集團已發行六批本金總額約為1.9百萬港元的承兌票據。承兌票據的年利率為5%)。本集團的現金主要用於應付營運資金需要。於2026年3月31日，本集團的銀行及現金結餘約為17.7百萬港元 (2025年3月31日：約4.2百萬港元)。

資產負債比率

於2026年3月31日，資本負債比率為306.9% (2025年3月31日：21.1%)。資本負債比率乃根據於有關期間結束時的債務總額除以總權益計算。為免生疑問，債務總額包括承兌票據及租賃負債。

OPERATION REVIEW

Outlook

The ordinary shares of HK\$0.01 each (the “Shares”) of the Company have been successfully listed on GEM on 14 February 2018. The Board considers that such public listing status will allow the Company to gain access to the capital market for corporate finance exercise, assist the Company in the future business development, enhance the Group’s corporate profile and recognition and strengthen its competitiveness.

Considering the decrease in market demand and the uncertainties brought by the post-COVID-19 era in the PRC, the Group has decided to suspend the launch of affordable locally manufactured fingerprint identification devices as part of the expansion plan of the business in the Southern China, and has reallocated part of the utilised net proceeds from the Listing to other business plans, namely (i) enhancement of the quality of after-sales services and strengthening of the operation support; (ii) improving the information technology system; (iii) research and development on touchless biometrics identification devices and AloT; and (iv) working capital.

The Group has also observed that there has been a change of market trend from touch biometrics identification devices to touchless biometrics identification devices due to increased public health awareness since the COVID-19 pandemic. As such, the Group has applied part of the net proceeds from the Listing for research and development on touchless biometrics identification devices and AloT. The Group plans to diversify the functions of its touchless biometrics identification devices and their applications by utilizing AloT in order to capture the market of touchless biometrics identification devices with healthcare-related functions. Looking forward, the Board takes the view that AloT and its functions can be applied in many different scenarios that the Group’s biometrics identification devices can be involved. The Group plans to capture and develop new markets in light of the growing popularity and application of AloT in daily life.

Employees and Remuneration Policies

As at 31 March 2026, the Group had a total of 165 employees. The Group’s staff cost for the year ended 31 March 2026 amounted to approximately HK\$38.8 million (2025: approximately HK\$31.9 million). The Group’s remuneration policies are in line with the prevailing market practise and are determined on the basis of performance, qualification and experience of individual employee. The Group recognises the importance of a good relationship with its employees. The remuneration payable to its employees includes salaries and allowances. Other benefits and incentives include training and share option.

營運回顧

展望

本公司每股面值0.01港元的普通股(「股份」)已於2018年2月14日在GEM成功上市。董事會認為，有關上市地位可讓本公司利用資本市場進行企業融資，協助本公司未來業務發展，提升本集團的企業形象及認受性以及加強其競爭力。

考慮到市場需求下降及中國後COVID-19時代所帶來的不明朗因素，本集團已決定暫停推出本地製造可負擔指紋識別裝置作為拓展華南地區業務計劃的一部分，並已重新分配部分已動用上市所得款項淨額予其他業務計劃，即(i)提高售後服務的質素及加強營運支援；(ii)改進資訊科技系統；(iii)研發非接觸式生物特徵識別裝置及AloT；及(iv)營運資金。

本集團亦觀察到，自COVID-19疫情以來公眾的健康意識提高，市場趨勢已從接觸式生物特徵識別裝置轉為非接觸式生物特徵識別裝置。因此，本集團已將部分上市所得款項淨額用於研發非接觸式生物特徵識別裝置及AloT。本集團計劃利用AloT多元化其非接觸式生物特徵識別裝置的功能及應用，以佔領具醫療相關功能的非接觸式生物特徵識別裝置市場。展望未來，董事會認為，AloT及其功能可應用於本集團生物特徵識別裝置可涉及的許多不同情景。鑑於AloT於日常生活中日益普及且廣泛應用，本集團計劃佔領及開發新市場。

In Hong Kong, the Group's employees have participated in the mandatory provident fund scheme prescribed by the Mandatory Provident Fund Schemes Ordinance (Chapter 485 of the Laws of Hong Kong). The Group did not have any significant capital commitments as at 31 March 2026 (2025: Nil).

Foreign Currency Risk

The Company does not have significant exposure to foreign currency risk.

The functional currency of the Group's entities are principally denominated in HK\$, Renminbi ("RMB") and MOP. The Group has certain exposure to foreign currency risk as some of its business transactions, assets and liabilities are denominated in currencies other than the functional currencies of respective Group entities such as United States dollars ("US\$"), RMB and EURO. The Group currently does not have a foreign currency hedging policy in respect of foreign currency transactions, assets and liabilities.

The Group did not engage in any derivatives agreement and did not commit to any financial instruments to hedge its foreign exchange exposure during the year ended 31 March 2026.

Significant Investments held, Material Acquisitions and Disposals of Subsidiaries, and Future Plans for Material Investments or Capital Assets

On 10 June 2025, the Group disposed of its entire interests in its wholly-owned subsidiary, Solution Expert Technology (Macau) Limited, a company incorporated in Macau, to an independent third party at a consideration of HK\$1 million.

1 BACKGROUND

The Company was incorporated and registered as an exempt company in the Cayman Islands with limited liability under the Companies Law (as revised) of the Cayman Islands on 16 October 2015.

The Company is an investment holding company. The Group is principally engaged in sales of biometrics identification devices and security products and provision of application software and repair and maintenance services during the year ended 31 March 2026 which is same as those of last year. The Company is listed on GEM of Stock Exchange on 14 February 2018 (stock code: 8379).

2 ABOUT THE REPORT

The Group primarily adopts the principles and basis of the “Environmental, Social and Governance Reporting Code” (“**ESG Code**”) as set out in Appendix C2 to the GEM Listing Rules, with an aim to establish a sound environmental, social and governance structure.

This report covers the Group’s overall performance in two subject areas, namely, environmental and social aspect of the business operations in Hong Kong office for the period from 1 April 2025 to 31 March 2026 (the “**Year**” or “**2026**”), unless otherwise stated.

This report comprises the review of environmental, social and governance areas (“**ESG**”), which sets out the Company and its major subsidiaries’ policies and practices in respect of three environmental aspects and eight social aspects in accordance with ESG Guide for the Year. This report is designed to allow the Company’s stakeholders, such as Shareholders, investors, customers, suppliers, employees, creditors, regulators and the general public to have comprehensive understanding of the long-term sustainability information of the Group. The Group seeks to balance the views and interests of these stakeholders through constructive conversation with a view to setting the course for long term prosperity. The Board is responsible for evaluating and determining the environmental, social and governance risks of the Group, and ensuring that relevant risk management and internal control systems are in place and operate effectively.

Unless otherwise specified, the reporting boundary of this report covers the principal businesses of the Group. We regularly review the scope of the ESG Report to ensure that significant impacts to the Group’s overall business portfolio are covered.

A. ENVIRONMENTAL

Environmental protection is one of the core values of the Group. The Group has proactively looked for and implemented new technology at various stages of its business in order to minimise its impact on the environment. The Group's products are designed to be safe and environmental friendly for customer use, meaning recyclable and safe to dispose materials are specified in its designs, and clean production processes are adopted in its business process. Moreover, unnecessary packaging that can cause harm to environment is not introduced into its products.

The Group considers environmental protection an essential component of sustainable and responsible business. The Group strives to negative impacts on the environment and to seek environmental friendly methods of operation. Given the nature of the Group's business, electricity was the most significant resources consumed in Hong Kong, Macau and the PRC during the Year.

The Current Environmental Policies

The Group's main task is to measure and report the efforts in reducing carbon footprints, promote waste reduction at source, enhance its waste disposal management and set targets on environmental performance. To minimise the environmental impacts concerning the activities, products and services, the Group will:

- comply with applicable legal requirements and other requirements which relate to the Group's environmental aspects, and to which the Group subscribes;
- identify environmental impacts associated with the operations and set the targets to reduce stress on the environment in consideration of social expectations;
- prevent pollution, reduce waste and minimise the consumption of resources from all daily operations and actively promote recycle, reuse and replace; and
- educate, train and motivate employees to develop a social viewpoint that enables them to conduct business activities in an environmentally responsible manner.

A. 環境

To achieve environmental protection, the Group encourages employees increase the use of e-statement or scanning instead of traditional photocopying to reduce the use of paper and greenhouse gas emissions; to switch-off all computers and office equipment (such as lighting and air-conditioner) at the end of each working day.

The Group generates no hazardous waste in its operation. However, there were non-hazardous waste which the management of the Group believe to be insignificant arose from the use of electricity during the Group's operation. Wastes produced by the Group during production were passed to qualified recycler for recycling.

A1.5 & A1.6

Since the management of the Group believe the non-hazardous waste is insignificant, there is no mitigation plan for handle non-hazardous waste.

A2.1 Use of resource

The Group is committed to minimising the impact of business activities on the environment, and supporting environmental protection. In particular, a number of initiatives designed to conserve resources were introduced to promote employee awareness of the need to achieve efficient utilisation of resources.

Energy conservation will not be effective without the support of employees. The Group has been encouraging employees to establish energy-saving habits at office, such as switching off lights and electronic appliances before leaving the office, as well as maintaining indoor temperature at 25.5°C. To further conserve electricity, the Group has leased energy-efficient high-speed printers for its daily operation. The Group believed that the usage of water consumption and usage of packing material is insignificant.

A4 Climate change

Global climate change is getting worse and global warming has been a serious problem. The Group, as a responsible enterprise, endeavoured to introduce measures as far as practicable, such as those mentioned in A2.1 above, to reduce greenhouse gas emissions from business operations.

Governance on climate change

The Group's oversight of climate change matters is led by the Board, which regularly reviews applicable regulations and guidelines, evaluates the Group's governance framework, and formulates measures to mitigate the impact of climate change on its operations and business. The Group remains committed to reducing greenhouse gas emissions across its business activities, striving to achieve both ecological sustainability and economic benefits.

Management and Strategy on climate change

We have identified that environmental, social, and climate-related matters may present both risks and opportunities to our business. These include: (i) risks associated with the physical impacts of climate change; (ii) risks arising from the transition to a lower-carbon economy; and (iii) opportunities:

(i) Physical risks

Climate change has intensified extreme weather events in recent years, creating physical risks with financial implications. For example:

- Damage to office and production premises or facilities may result in higher maintenance and prevention costs.
- Employee safety may be at risk.

To manage extreme weather conditions, the Group adopts precautionary and protective measures such as home-office arrangements, adjustments to work schedules, and redeployment of resources. These actions are designed to safeguard employee safety, minimize disruptions to business processes, and prevent physical damage to the Group's assets.

A4 氣候變化

Being a responsible business and employer, the Group is committed to consistently looking for ways to meet the corporate social responsibilities. The Group focuses on the welfare of its staff, environment and community as well as its business partners.

The Group places a significant emphasis on developing human capital, provides competitive remuneration and welfare packages. Promotion opportunities and salary adjustments are benchmarked against individual performance. Employees are entitled to benefits such as annual leave, sick leave, maternity leave, marriage leave, funeral leave and medical coverage in accordance with local regulations.

During the Year, the Group has had no non-compliance with any laws and regulations on employment.

The employee handbook of the Group's PRC subsidiary had been developed in accordance with the Labour Law of the PRC and has been distributed to all employees since they joined. The remuneration policies are determined on the basis of performance, qualification and experience of individual employee. The remuneration generally includes salaries and allowances.

During the Year, the Group's PRC subsidiary had subscribed to those basic pension insurance, basic medical insurance, unemployment insurance, occupational injury insurance, maternity insurance as prescribed by the Social Insurance Law of the PRC, as well as housing fund schemes as prescribed by the Regulations on the Administration of Housing Fund.

Employees' wages, overtime payments and related benefits are made not less than the local government's minimum requirements. The normal working hours for general employees are generally 8 hours a day and 40 hours a week. Integrated computation of working hours is implemented with reference to the requirements of the Labour Law of the PRC.

B3 Development and Training

Staff development forms an important aspect of the Group's human resources policy. The Group places a strong emphasis on providing training to its employees to retain appropriate and suitable personnel for its long-term development.

The Group has committed to provide on-the-job education and training to its employees in order to enhance their knowledge and skills. All employees are encouraged to enhance their skills and knowledge at every opportunity in order to perform their current job more efficiently and effectively and to be better prepared for career opportunities which may arise. During the Year, regular training courses were provided to the employees included but not limited to orientation training, technical training and quality training.

Performance evaluations are initiated annually. In order to recognise the value in the skill and experience of the Group's employees, the Group has adopted a policy that any promotions will be considered internally first before hiring any outside staff. It is the Group's policy to select the most suitable candidate for appointment to a higher rank based on merit, rather than on the seniority of the candidates.

B4 Labour Standard

The Group is fully awarded that child labour and forced labour violate fundamental human rights, International Labour Conventions and Recommendations and poses a threat to sustainable social and economic development. Therefore, the Group strictly complied with relevant laws and regulations. The Group prohibits the hiring of child labour by reviewing the actual age of the interviewee during the recruitment process, including the examination of identity documents and detailed records. The Group only carries out the requirements of standard labour contract and does not adopt any means to unfairly restrict the employment relationship between employee and the enterprise by, for example, withholding a deposit or identity documents.

For entry registration, all employees must present to the Group valid documents as follows: (i) identity card and vocational qualification certificate; (ii) social security card; (iii) medical or health certificate; (iv) recent photos; and (v) other relevant information and documents. The above procedures can ensure no child labour will be employed.

Being people-oriented, the Group has hosted various social events and activities such as company trips and parties for its employees with the aim of promoting work-life balance.

During the Year, the Group had no non-compliance with any child labour and forced labour laws.

B5 Supply Chain Management

The Group has the greatest respect for the laws and regulations that govern its business. The Group strives to adhere to international best practices and conduct fair and unbiased procurement processes when dealing with suppliers.

The Group adheres to the principle of transparency and implements the value of honesty, integrity and fairness in its supply chain management. The Group's procurement procedures provide directions and guidelines on evaluation and engagement when dealing with suppliers of goods and services to ensure business is conducted with legally, financially and technically-sound entities. In addition, approval procedures are in place to ensure that supplier engagements are monitored and approved by the appropriate level of management.

B4 勞工準則

Performance of suppliers impose direct impact on the sustainability of the Group's operation. The Group implements the procedures on selection of suppliers strictly to minimize both the environmental and social risks of the Group's supply chain. A systematic supplier management mechanism has been set up to closely monitor the performance of suppliers. As at 31 March 2026, the Group has 62 major suppliers.

B6 Product Responsibility

A high priority for the Group is to ensure customer satisfaction in terms of the products and services. Strenuous efforts are made to ensure compliance with the relevant laws and regulations relating to product health and safety, advertising, labelling and privacy matters of the jurisdictions in which the Group operates. The Group requires its employees to comply with applicable governmental and regulatory laws, rules, codes and regulations.

Quality Control and Product Warranty

Instruction guidelines regarding product quality inspection, return and repair of defective products have been set to further ensure that the quality of our products are up to standard and customers who have received verified defective products can get their replacement. Upon receiving a defective unit of a product, the unit is subject to different procedures depending on the situation, which will be accepted for exchange or repair if the customer can provide valid purchase and warranty documents. Our customer service team is responsible for monitoring and handling customer complaints and a set of procedures have been formulated so that complaints can be categorized and solved by the designated staff timely.

Data Privacy Protection

The Group emphasises the importance of protecting and safe-guarding its customers' privacy, especially for money lenders' information. Thereby, the Group would be cautious upon the collection, procession and usage of customers' personal data in order to comply with the provisions of the Personal Data (Privacy) Ordinance.

During the Year, the Group did not have any products subject to recall and did not receive any complaint from its customers in relation to either the quality of its services or products. The Group had no non-compliance cases regarding violations of relevant laws and regulations on product responsibility and data privacy.

B6 產品責任

確保顧客滿意我們的產品及服務是本集團的首要任務。本集團致力確保本集團在產品健康與安全、廣告、標籤以及私隱權方面遵守本集團經營所在司法權區的相關法律及法規。本集團要求僱員遵守適用的政府及監管法律、規則、守則及法規。

B7 Anti-corruption

Corruption, bribery or fraud in any form is strictly prohibited. The Group's anti-corruption policies set out standards of conduct to which all employees are required to adhere in order to promote the integrity environment in the workplace.

The management believes that the integrity of business is the foundation of corporate social responsibility, as well as a fundamental element for a business's competitive advantage and sustainability. The Group is committed to the highest possible standards of openness, probity and accountability.

To combat corruption and to govern conflicts of interest, unless with the Group's approval, Directors and employees are prohibited from accepting any valuable items from co-workers, customers, suppliers or other stakeholders. Unless with approval the Board, senior management members are also prohibited from engaging in any activities that involve a potential conflict of interest with the Group or may do harm to the Group's overall interests. Breaches are subject to disciplinary actions, including termination of employment contracts where necessary.

Various policies have also been formulated to accord with the Securities and Futures Commission's Guideline on Anti-Money Laundering and Counter-Terrorist Financing, including the basic procedures for customer identification and due diligence, suspicious transactions report and recordkeeping. Ongoing staff training has also been carried out to ensure each of the employees is fully aware of these policies.

During the Year, the Group provide 8 training hours in relation to anti-corruption to its staffs.

CORPORATE GOVERNANCE PRACTICES

APPOINTMENT AND RE-ELECTION OF DIRECTORS

All Directors are appointed for an initial term of three years and subject to retirement by rotation and eligible for re-election in accordance with the Company's articles of association (the "**Articles**"). At each annual general meeting, not less than one third of the Directors then in office shall retire and every Director is subject to retirement by rotation at least once every three years.

Each executive Director, non-executive Director and independent non-executive Director is appointed for an initial term of three years and renewable for successive terms of one year each commencing from the day next after the expiry of the then current term, subject to rotation, removal, vacation, or termination of such office as set out in the Articles or the disqualification to act as a Director under the Articles. Each independent non-executive Director is further required to inform the Company as soon as practicable if there is any change that may affect his independence and must provide an annual confirmation of his independence to the Company.

All existing executive Directors, non-executive Director and independent non-executive Directors are entitled to a fixed remuneration per month or fee per annum respectively. The remuneration of each Director is subject to the annual review of the Board with reference to his/her contribution in terms of time, effort and his/her expertise.

Details of remuneration paid to each of the Directors during the year are disclosed in Note 13 to the financial statements.

All Directors are entitled to be reimbursed for reasonable expenses incurred during the performance of their duties to the Company and are eligible for share options under the Share Option Scheme.

BOARD COMMITTEES

The Board has established three board committees, namely, the audit committee (the "**Audit Committee**"), the remuneration committee (the "**Remuneration Committee**") and the nomination committee (the "**Nomination Committee**"), all with specific terms of reference clearly defining the powers and responsibilities of the respective board committees. RISK MANAGEMENT AND INTERNAL CONTROLS

The Group emphasises the importance of a sound internal control system which is also indispensable for mitigating the Group's key risk exposures. The Group's system of internal control is designed to provide reasonable, but not absolute, assurance against material misstatement or loss and to manage and eliminate risks of failure in operational systems and fulfillment of the business objectives. The internal control system is reviewed on an ongoing basis by the Board in order to make it practical and effective in providing reasonable assurance in relation to protection of material assets and Shareholders' interests. During the year under review, McMillan Woods Corporate Service Limited has reviewed the risk management and internal control systems of the Group and has provided written reports to the Audit Committee.

The Group has adopted a three-tier risk management approach to identify, assess and manage different types of risks. At the first line of defence, business units are responsible for identifying, assessing and monitoring risk associated with each business or transaction. The management, as the second line of defence, defines rule sets and models, provide technical support, develops new system and oversees portfolio management. It ensures risks are within acceptable range and that the first line of defence is effective. As the final line of defence, McMillan Woods Corporate Service Limited assists the Audit Committee to review the first and second lines of defence.

The Group is committed to the identification, evaluation and management of risks associated with its business activities through ongoing assessment of a risk register, by considering the likelihood and impact of each identified risk. The Group has implemented an effective control system which includes a defined management structure with limits of authority, a sound management system and periodic review of the Group's performance by the Audit Committee and the Board.

The Group regards periodic review of internal control system as an important part of the Board's oversight function. The Group has not set up an internal audit function, however, the Group has engaged an external consultant, McMillan Woods Corporate Service Limited, to conduct review on the internal control system of the Group. The review shall be conducted once every year. During the year ended 31 March 2026, a review has been conducted and the Directors considered the internal control system of the Group to be effective and adequate.

Through the Audit Committee, the Board has conducted annual review of the effectiveness of the Group's risk management and internal control systems for the year ended 31 March 2026, covering the material financial, operational and compliance controls, which are considered effective and adequate.

The Audit Committee has reviewed the adequacy of resources, qualifications and experience, training and budget of the accounting, internal audit and financial reporting functions on an annual basis.

The executive Directors have responsibility for approving certain announcements and/or circulars to be issued by the Company under powers delegated by the Board from time to time.

The Company has put in place procedures on handling and dissemination of inside information in a timely manner in such a way so as not to place any person in a privileged dealing position and to allow time for the market to price the listed securities of the Company with the latest available information. The Company has appropriate internal control and reporting systems to identify and assess potential inside information. Dissemination of inside information of the Company shall be conducted by publishing the relevant information on the websites of the Stock Exchange and the Company, according to the requirements of the GEM Listing Rules.

SHAREHOLDERS' RIGHTS TO CONVENE EXTRAORDINARY GENERAL MEETING

In order to safeguard shareholders' interests and rights, separate resolutions are proposed at Shareholders' meetings on each substantial issue, including the election of individual Directors, for Shareholders' consideration and voting.

The following procedures for Shareholders of the Company to convene an extraordinary general meeting are subject to the Articles, and the applicable legislation and regulation, in particular the GEM Listing Rules:

- (i) any one or more shareholders of the Company holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company (the "**Eligible Shareholder(s)**") carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition to the Board or the company secretary of the Company (the "**Company Secretary**"), to require an extraordinary general meeting (the "**EGM**") to be called by the Board for the transaction of any business specified in such requisition pursuant to Article 64 of the Articles; and
- (ii) if within 21 days of the deposit of the requisition, the Board fails to proceed to convene such EGM, the requisitionist(s) himself/ themselves may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

CLARIFICATIONS IN RESPECT OF THE POLL RESULTS OF 2025 ANNUAL GENERAL MEETING

Reference is made to the announcement of the Company dated 22 September 2025 (the “**Announcement**”) in relation to, *inter alia*, the poll results of the annual general meeting for the year 2025 (the “**AGM**”) held on 22 September 2025. Unless otherwise stated, terms used in this announcement shall have the same meanings as those defined in the Announcement.

Following a post-AGM review by the Company and Tricor Investor Services Limited (the Hong Kong Branch Share Registrar of the Company and the scrutineer of the AGM, the “**Scrutineer**”), two clerical errors were identified in the tabulation of proxy votes for Resolutions 5 to 8 (the “**Relevant Resolutions**”):

1. Clerical oversight in signature verification for one shareholder: In respect of one shareholder for whom two proxy forms were received, there was an inadvertent oversight in the signature verification process. Specifically, the earlier proxy form (received on 12 September 2025) contained both the shareholder’s English and Chinese signatures, whereas the later proxy form (received on 19 September 2025) contained only an English signature. Following further verification requested by the Company, the Scrutineer confirmed that the English signature on the later proxy form did not match the specimen signature maintained in its internal system, and only the Chinese signature on the earlier proxy form matched the specimen signature. Accordingly, the earlier proxy form was the only valid proxy form. As such, 450,000 votes originally counted as “For” for the Relevant Resolutions (according to the later proxy form) should correctly have been recorded as “Against” for the Relevant Resolutions (according to the earlier proxy form).
2. Clerical error in proxy supersession for one shareholder: In respect of another shareholder for whom two proxy forms were received, the later proxy form (received on 19 September 2025), which contained a signature matching the specimen signature in the Scrutineer’s internal records and should have superseded the earlier proxy form (received on 12 September 2025), was inadvertently overlooked by the Scrutineer. Accordingly, 10,000 votes originally counted as “Against” for the Relevant Resolutions (according to the earlier proxy form) should correctly have been recorded as “For” for the Relevant Resolutions (according to the later proxy form).

These are purely clerical mistakes and the adjustments have been verified by the Scrutineer.

茲提述本公司日期為2025年9月22日的公佈(「該公佈」)，內容有關(其中包括)於2025年9月22日舉行的2025年度股東週年大會(「股東週年大會」)投票表決結果。除另有說明外，本公佈所用詞彙與該公佈所界定者具有相同涵義。

經本公司與卓佳證券登記有限公司(本公司香港股份過戶登記分處及股東週年大會的監票人，「監票人」)於股東週年大會後進行審閱後，發現第5至8項決議案的受委代表投票統計存在兩處文書錯誤(「相關決議案」)：

1. 一名股東的簽名核實程序中出現文書疏漏：就一名提交了兩份代表委任表格的股東而言，其簽名核實過程中出現無心疏忽。具體而言，較早提交的代表委任表格(於2025年9月12日接獲)同時載有股東的英文及中文簽名，而較後提交的代表委任表格(於2025年9月19日接獲)則僅載有英文簽名。經本公司要求進行進一步核實後，監票人確認，較後提交的代表委任表格上的英文簽名與其內部系統所存檔的簽名樣本不符，而僅有較早提交的代表委任表格上的中文簽名與簽名樣本相符。因此，較早提交的代表委任表格為唯一有效的代表委任表格。據此，原先計入「贊成」相關決議案的450,000票(根據較後提交的代表委任表格)應正確記錄為「反對」相關決議案(根據較早提交的代表委任表格)。
2. 一名股東的受委代表取代事宜出現文書錯誤：就另一名已提交兩份代表委任表格的股東而言，監票人不慎忽略了較後提交的代表委任表格(於2025年9月19日接獲)，該表格上的簽名與監票人內部紀錄中的簽名樣本相符，且本應取代較早提交的代表委任表格(於2025年9月12日接獲)。因此，原先計入「贊成」相關決議案的10,000票(根據較早提交的代表委任表格)應正確記錄為「反對」相關決議案(根據較後提交的代表委任表格)。

上述各項純屬文書錯誤，有關調整已由監票人核實。

The Company would like to provide the following information regarding the delay in publication of the Annual Results:

本公司謹此就延遲刊發年度業績提供以下資料：

(i) Reasons for the delay in publication of the Annual Results

The primary reason for the delay in the publication of the Annual Results was the additional time required to complete the confirmation procedures and the auditors' review of the expected credit loss assessment for trade and other receivables. The Company wishes to explain the reasons for the delay as follows:

(a) *expansion of mainland operations*

During the year, the Group focused on developing its operations in Mainland China. The expanded business operations comprised (1) provision of online information and digital marketing services; (2) provision of management and business solutions services; and (3) lifestyle and wellness services.

As a result of the increased business activities, additional receivable and payable balances arose from the provision of management and business solutions services. Accordingly, 3 additional confirmations relating to receivables with an aggregate amount of HK\$2,928,000 and 21 additional confirmations relating to payables with an aggregate amount of HK\$21,722,000 were required as at the reporting date. The auditor also performed additional relevant expected credit loss assessments.

(b) *unforeseeable absence of hong kong finance manager*

The Hong Kong finance manager unfortunately underwent two urgent major surgeries between April and May 2026, with two separate hospital admissions and discharges and was hospitalised for approximately one and a half months. After discharged from the hospital, the Hong Kong finance manager was unable to fully resume normal duties until mid-to-late June due to his health condition. This unforeseeable circumstance directly affected the coordination of audit procedures.

(c) *mainland finance team's limited experience*

The Mainland finance personnel were relatively new to their roles and lacked familiarity with Hong Kong audit requirements. This contributed to a delay in providing the information requested by the auditors.

(i) 延遲刊發年度業績的原因

延遲刊發年度業績的主要原因為完成確認程序及核數師審閱貿易及其他應收款項的預期信貸虧損評估需要額外時間。本公司謹此闡述延遲原因如下：

(a) 內地業務擴展

年內，本集團專注於發展其於中國內地的業務。擴展的業務營運包括(1)提供網上資訊及數碼營銷服務；(2)提供管理及業務解決方案服務；及(3)生活及健康服務。

由於業務活動增加，提供管理及業務解決方案服務產生了額外的應收款項及應付款項結餘。因此，於報告日期需要發出3份有關應收款項(總額為2,928,000港元)的額外確認書及21份有關應付款項(總額為21,722,000港元)的額外確認書。核數師亦已進行額外的相關預期信貸虧損評估。

(b) 香港財務經理不可預見的缺勤

香港財務經理不幸於2026年4月至5月期間接受了兩次緊急大型手術，期間兩度入院及出院，住院約一個半月。出院後，由於健康狀況，香港財務經理直至6月中下旬方能全面恢復正常職務。此不可預見的情況直接影響審核程序的協調。

(c) 內地財務團隊經驗有限

內地財務人員相對較新入職，對香港審核要求缺乏熟悉度。這導致延遲提供核數師要求的資料。

(d) *subsequent completion and auditor agreement*

After the Hong Kong finance manager fully resumed work, the outstanding confirmation letters were eventually issued, and the confirmation procedures were completed and the auditors subsequently received sufficient confirmation replies to their satisfaction. Regarding expected credit loss assessment, after the finance manager fully resumed work and verified the nature and subsequent settlement of receivables, the auditors agreed with the assessment. From 30 June 2026 to date, there have been no changes to the amount of expected credit loss.

(d) 其後完成及核數師同意

於香港財務經理全面復工後，尚未發出的確認函件最終得以發出，而確認程序已告完成，且核數師其後收到令其滿意的充足確認回覆。就預期信貸虧損評估而言，於財務經理全面復工並核實應收款項的性質及其後結算後，核數師同意該評估。自2026年6月30日至今，預期信貸虧損金額並無變動。

(ii) **Measures taken after the audit committee became aware of the possible delay**

The Audit Committee first became aware of the potential risk of delay in the publication of the Results between 12 June to 15 June 2026, when the external auditor informed the Audit Committee that the confirmation procedures for the increased volume of receivables and payables relating to the Group's expanded Mainland operations were progressing more slowly than anticipated, and that the hospitalisation of the Hong Kong finance manager directly affected the coordination of audit procedures. The Audit Committee continued to monitor the situation closely and was formally updated on the possibility that the Company might not be able to meet the 30 June 2026 publication deadline by management on or around 25 June 2026.

Upon becoming aware of the matters leading to the potential delay, the Audit Committee took the following actions at the material time to avoid a delay in annual results publication:

(a) **Immediate Engagement with Management and Auditors:** The Audit Committee held meetings with management and the external auditor after becoming aware of the potential risk of delay in the publication of the Results to understand the status of outstanding audit procedures, in particular the confirmation letter process and the review of the expected credit impairment model for receivables, and to explore ways to expedite the process.

(b) **Regular Monitoring and Follow-up:** The Audit Committee required management to provide weekly progress updates on the audit status, including the issuance and receipt of confirmation letters and the progress of the expected credit loss assessment, and to escalate any significant issues to the Audit Committee immediately.

(ii) **審核委員會知悉可能延遲後採取的措施**

審核委員會於2026年6月12日至6月15日期間首次知悉延遲刊發業績的潛在風險，當時外聘核數師告知審核委員會，有關本集團擴展內地業務所帶來應收款項及應付款項增加の確認程序進展較預期緩慢，而香港財務經理的住院治療直接影響審核程序的協調。審核委員會繼續密切監察情況，並於2026年6月25日或前後獲管理層正式告知本公司可能無法趕及2026年6月30日的刊發截止日期。

於知悉導致可能延遲的事項後，審核委員會於關鍵時間採取以下行動以避免延遲刊發年度業績：

(a) **即時與管理層及核數師接洽：**審核委員會在知悉延遲刊發業績的潛在風險後，與管理層及外聘核數師舉行會議，以了解未完成審核程序的狀況，特別是確認函件流程及應收款項預期信貸減值模型的審閱，並探討加快流程的方法。

(b) **定期監察及跟進：**審核委員會要求管理層每週提供審核狀況的進度更新，包括確認函件的發出及收回情況以及預期信貸虧損評估的進展，並將任何重大問題即時上報審核委員會。

- (c) Direct Communication with the Auditor: The Audit Committee communicated directly with the external auditor to understand the specific audit evidence required and to assess whether any alternative procedures could be performed to obtain sufficient appropriate audit evidence within a shorter timeframe.
- (d) Facilitation of Resources: The Audit Committee recommended that the Company arrange training sessions on Hong Kong financial reporting requirements to bridge the temporary manpower gap arising from the Mainland finance team's limited familiarity with Hong Kong financial reporting requirements, and ensure continuity of the audit coordination work.
- (e) Review of Contingency Plans: The Audit Committee reviewed and discussed with management the contingency measures and the proposed timeline for completing the outstanding audit procedures, and urged management to take all necessary steps to minimise the delay and to publish the Results as soon as practicable.

(iii) Measures to prevent re-occurrence of delay in publication of results in the future

To prevent re-occurrence of such a delay in results publication in the future, the Company will implement the following improvement measures:

- (a) Designate a senior staff of the Company, who has over 10 years of experience in the finance management in the Company, as the acting manager to be fully briefed on the audit timeline, process and matters so that the person can step in immediately if the primary manager becomes unavailable.
- (b) Adopt a policy requiring immediate notification of the Audit Committee, or the Board if a critical finance team member requires sudden, extended leave during the audit period. Under this policy, any critical finance team member applying for sudden extended leave shall submit the leave request to their department head. The department head then shall make a notification to the Chairman of the Audit Committee, or to the Chairman of the Board if the former is unreachable, via email, telephone or other instant messaging channels within one day of becoming aware of the leave. This allows the Company to quickly procure external resources if necessary.

- (c) 與核數師直接溝通：審核委員會直接與外聘核數師溝通，以了解所需的具體審核憑證，並評估是否可在較短時間框架內執行任何替代程序以獲取充足適當的審核憑證。

- (d) 促進資源調配：審核委員會建議本公司安排有關香港財務報告要求的培訓課程，以填補因內地財務團隊對香港財務報告要求熟悉度有限而產生的短期人手缺口，並確保審核協調工作的連續性。

- (e) 審閱應急計劃：審核委員會與管理層審閱及討論應急措施及完成未完成審核程序的建議時間表，並敦促管理層採取一切必要措施以盡量減少延遲，並盡快刊發業績。

(iii) 防止日後再次延遲刊發業績的措施

為防止日後再次出現有關延遲刊發業績的情況，本公司將實施以下改進措施：

- (a) 指定一名在本公司擁有超過10年財務管理經驗的本公司高級職員為代理經理，全面了解審核時間表、流程及事項，以便在主要經理未能履職時可即時接手。
- (b) 採納一項政策，規定倘審核期間關鍵財務團隊成員需要突然長期休假，須即時通知審核委員會或董事會。根據此政策，任何申請突然長期休假的關鍵財務團隊成員須向其部門主管提交休假申請。部門主管其後須在知悉休假後一日內，透過電郵、電話或其他即時通訊渠道通知審核委員會主席，或倘無法聯絡審核委員會主席，則通知董事會主席。此舉使本公司能在必要時迅速調配外部資源。

- (c) Institute regular, formal training sessions for the Mainland finance team on topics of (a) HKFRS Accounting Standards (HKFRS) on expected credit loss modeling; (b) HKFRS on substantive testing procedures; (c) key differences between HKFRS and PRC GAAP; and (d) other specific auditor expectations. The training will be conducted annually and completed by 30 September each year. It is mandatory for the accounting department head of the Mainland finance team.
- (d) Assign a dedicated liaison within the Hong Kong team to continuously monitor the Mainland team's reporting quality throughout the year. The liaison team comprises the company secretary, the finance manager, the financial supervisor, and the respective department heads of the finance teams of all Mainland subsidiaries.
- (e) Adopt a policy which requires that all audit request lists, timelines, and compliance requirements are clearly documented and distributed in both English and simplified Chinese to prevent misinterpretation.
- (f) Establish a regular communication mechanism whereby the Group's finance department and the finance departments of its subsidiaries conduct joint working meetings every two months to facilitate exchange of information, provide technical training and address accounting issues identified, thereby reducing potential risks arising during the consolidation audit process. In addition, audit confirmation procedures will commence one month before the financial year-end.
- (c) 為內地財務團隊設立定期正式培訓課程，涵蓋以下主題：(a)有關預期信貸虧損建模的香港財務報告準則會計準則（香港財務報告準則）；(b)有關實質性測試程序的香港財務報告準則；(c)香港財務報告準則與中國公認會計準則的主要差異；及(d)其他具體的核數師預期。培訓將每年進行，並於每年9月30日前完成。內地財務團隊的會計部門主管必須參加。
- (d) 指派香港團隊內的專責聯絡人，全年持續監察內地團隊的報告質量。聯絡團隊由公司秘書、財務經理、財務監督員及所有內地附屬公司財務團隊的各自部門主管組成。
- (e) 採納一項政策，規定所有審核要求清單、時間表及合規要求均須以英文及簡體中文清晰記錄及分發，以防止誤解。
- (f) 建立定期溝通機制，據此，本集團財務部門及其附屬公司財務部門每兩個月舉行聯合作業會議，以促進資訊交流、提供技術培訓及處理已識別的會計問題，從而減少綜合審核過程中產生的潛在風險。此外，審核確認程序將於財政年度結束前一個月開始。

AMENDMENTS TO CONSTITUTIONAL DOCUMENTS

The Company proposed to adopt the third amended and restated memorandum and articles of association (the “**New Memorandum and Articles of Association**”) in order to bring the then existing memorandum and articles of association up to date and in line with the latest regulatory requirements in relation to the paperless listing regime, the electronic dissemination of corporate communications by listed issuers and the relevant amendments made to the Listing Rules which took effect on 31 December 2023. The Company proposed to adopt the New Memorandum and Articles of Association in substitution for and to the exclusion of the then existing memorandum and articles of association with effect from the proposed change of company name becoming effective and passing of the relevant special resolution at the annual general meeting of the Company held on 9 September 2024 (the “**Conditions**”). However, as one of the Conditions, which is the proposed change of company name becoming effective, has not been fulfilled by proposing the relevant resolution at the annual general meeting of the Company held on 9 September 2024, it is not feasible to adopt the New Memorandum and Articles of Association in 2024.

During the Reporting Period, the special resolution regarding the change of the Company's legal registered name in Chinese was duly passed by the Shareholders at the annual general meeting convened on 22 September 2025; the Registry of Companies in the Cayman Islands issued the Certificate of Incorporation on Change of Name on 2 October 2025, with the new Chinese legal name “盈證國際控股有限公司” taking effect from 29 September 2025. The relevant procedures for registration of the change were completed with the Companies Registry in Hong Kong on 3 November 2025 in accordance with Section 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong). In addition, the Company's Chinese stock short name on GEM was changed from “懶豬科技” to “盈證國際”, effective from 9:00 a.m. on 5 December 2025. Following the completion of the aforementioned change of company name, the Company has formally adopted the New Memorandum and Articles of Association during the Reporting Period and completed all necessary statutory filing procedures.

PRINCIPAL ACTIVITIES AND ANALYSIS OF OPERATIONS

The principal activity of the Company is investment holding. Details of the principal activities principal subsidiaries are set out in note 35 to the financial statements. There were no significant changes in the nature of the Group's principal activities during the year.

STRATEGIC COOPERATION FRAMEWORK AGREEMENT

On 20 January 2026, Shenzhen Yingke Internet Technology Co., Ltd. ("**Yingke Internet**"), an indirect wholly-owned subsidiary of the Company, entered into a legally binding strategic cooperation agreement with Ling Xuan (Hainan) Technology Co., Ltd. ("**Ling Xuan (Hainan)**"), pursuant to the Cooperation Agreement, Yingke Internet and Ling Xuan (Hainan) jointly established Yinghe Digital Intelligence (Hainan) Technology Co., Ltd., in which they hold 51% and 49% equity interest respectively, to carry out businesses relating to artificial intelligence and industrial digital transformation. Details of the above are set out in the Company's announcement dated 13 February 2026.

The Group's inventories had a net carrying amount of approximately HK\$19,486,000 (after deducting an allowance of approximately HK\$4,245,000) as at 31 March 2026. 於2026年3月31日，貴集團存貨的賬面淨值約為19,486,000港元（經扣除撥備約4,245,000港元後）。

The Group operates in an industry where technological development may significantly affect the valuation of inventories as its products would become slow-moving or outdated when products with new technology emerge.

During the course of business, the Group would grant credit terms to its customers ranged between 30 to 90 days. The Group would perform periodic assessment on the impairment of trade receivables by basing on information including credit risk characteristics of each customer, historical ageing and settlement records, subsequent settlement status, expected timing and amount of recovering outstanding balances, and on-going trading relationships with the relevant customers and forward-looking information that may impact its customers' abilities to repay the outstanding trade receivables in order to estimate the expected credit losses ("ECL") for the impairment assessment.

1. GENERAL INFORMATION

The Company was incorporated in the Cayman Islands as an exempt company with limited liability under the Companies Law (as revised) of the Cayman Islands on 16 October 2015. The address of its registered office is P.O. Box 1350, Clifton House, 75 Fort Street, Grand Cayman, KY1-1108, Cayman Islands. The address of its principal place of business is located at Room 504, 5/F, Bupa Centre, 141 Connaught Road West, Hong Kong. The Company's shares are listed on GEM of The Stock Exchange of Hong Kong Limited (the "**Stock Exchange**") since 14 February 2018 (the "**Listing**").

The Company is an investment holding company. The principal activities of its subsidiaries are set out in note 35 to the consolidated financial statements.

2. BASIS OF PREPARATION

The consolidated financial statements have been prepared in accordance with HKFRS Accounting Standards as issued by the Hong Kong Institute of Certified Public Accountants (the "**HKICPA**"). HKFRS Accounting Standards comprise all applicable individual Hong Kong Financial Reporting Standards ("**HKFRSs**"); Hong Kong Accounting Standards ("**HKAS**"); and interpretations ("**Ints**"). The consolidated financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on GEM of the Stock Exchange (the "**GEM Listing Rules**") and with the disclosure requirements of the Hong Kong Companies Ordinance. Material accounting policy information adopted by the Group are discussed below.

The HKICPA has issued certain new and amendments to HKFRS Accounting Standards that are first effective or available for early adoption for the current accounting period of the Group. Note 3 provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the Company and its subsidiaries (collectively referred to as the "**Group**") for the current and prior accounting periods reflected in the consolidated financial statements.

1. 一般資料

HKFRS 18 “Presentation and Disclosure in Financial Statements”

HKFRS 18 will replace HKAS 1 “Presentation of financial statements”, introducing new requirements that will help to achieve comparability of the financial performance of similar entities and provide more relevant information and transparency to users. Even though HKFRS 18 will not impact the recognition or measurement of items in the financial statements, HKFRS 18 introduces significant changes to the presentation of financial statements, with a focus on information about financial performance present in the statement of profit or loss, which will affect how the Group present and disclose financial performance in the consolidated financial statements.

The new accounting standard introduces the following key new requirements:

- Entities are required to classify all income and expenses into five categories in the statement of profit or loss, namely the operating, investing, financing, discontinued operations and income tax categories. Entities are also required to present a newly-defined operating profit subtotal. Entities’ net profit will not change.
- Management-defined performance measures (“MPMs”) are disclosed in a single note in the financial statements.
- Enhanced guidance is provided on how to group information in the financial statements.

In addition, all entities are required to use the operating profit subtotal as the starting point for the statement of cash flows when presenting operating cash flows under the indirect method.

The Group is currently assessing the impact of HKFRS 18, with respect to the structure of the Group's consolidated statement of profit or loss and other comprehensive income, the consolidated statement of cash flows and the additional disclosures required for MPMs. The Group is also assessing the impact on how information is grouped in the consolidated financial statements. Preliminary assessments indicate the following key impacts:

- The Group will need to reclassify certain income and expense items (e.g., foreign exchange gains/losses) into the new categories, namely investing and financing categories.
- The Group disclose certain MPMs (e.g., adjusted operating profits and adjusted earnings before interest, tax, depreciation and amortisation) in its results announcements and the annual report. Under HKFRS 18, this will likely require additional disclosure for the MPMs within the notes to the consolidated financial statements.
- The consolidated statement of cash flows will also be impacted, as the operating profit subtotal will be the required starting point for the indirect method.

本集團目前正在評估香港財務報告準則第18號對本集團綜合損益及其他全面收益表、綜合現金流量表的結構，以及管理層表現計量所需額外披露的影響。本集團亦正在評估對綜合財務報表中資料分類方式的影響。初步評估顯示以下主要影響：

- 本集團將須把若干收入及開支項目(例如匯兌收益／虧損)重新分類至新類別，即投資及融資類別。

These consolidated financial statements have been prepared under the historical cost convention, unless mentioned otherwise in the material accounting policy information below (e.g. certain financial instruments that are measured at fair value).

The preparation of financial statements in conformity with HKFRS Accounting Standards requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the Group's accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the consolidated financial statements are disclosed in note 5.

The material accounting policy applied in the preparation of these consolidated financial statements are set out below.

(a) Consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries made up to 31 March. The financial statements of the subsidiaries are prepared for the same reporting year as that of the Company. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group. Subsidiaries are entities over which the Group has control. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. The Group has power over an entity when the Group has existing rights that give it the current ability to direct the relevant activities, i.e. activities that significantly affect the entity's returns.

When assessing control, the Group considers its potential voting rights as well as potential voting rights held by other parties, to determine whether it has control. A potential voting right is considered only if the holder has the practical ability to exercise that right.

Subsidiaries are consolidated from the date on which the Group obtains control and continue to be consolidated until the date when such control ceases.

編製符合香港財務報告準則會計準則的財務報表須採用若干關鍵會計估計，亦要求管理層於應用本集團會計政策的過程中作出判斷。涉及高度判斷或複雜程度的範疇，或對綜合財務報表有重大影響的假設及估計的範疇於附註5中披露。

在編製該等綜合財務報表時應用的重大會計政策載列如下。

(a) 綜合

綜合財務報表包括本公司及其附屬公司截至3月31日止的財務報表。附屬公司的財務報表乃就與本公司相同的報告年度編製。附屬公司的會計政策已按需要作出改變以確保與本集團採納的政策一致。附屬公司指本集團控制的實體。當本集團通過參與某實體而承擔可變回報的風險或享有可變回報，並且有能力運用對該實體的權力影響該等回報，本集團即控制該實體。當本集團擁有現有權利，使本集團目前有能力主導相關活動（即對實體的回報產生重大影響的活動），本集團對該實體擁有權力。

在評估是否擁有控制權時，本集團考慮其潛在表決權以及其他方所持有的潛在表決權，以釐定其是否有控制權。只有在持有人有實際能力行使有關權利時，方考慮潛在表決權。

附屬公司在本集團取得控制權之日起綜合入賬，並繼續綜合入賬直至控制權終止當日為止。

(a) Consolidation (continued)

The gain or loss on the disposal of a subsidiary that results in a loss of control represents the difference between (i) the fair value of the consideration of the sale plus the fair value of any investment retained in that subsidiary; and (ii) the Company's share of the net assets of that subsidiary plus any remaining goodwill and any accumulated foreign currency translation reserve relating to that subsidiary.

Intragroup transactions, balances, unrealised profits are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

Non-controlling interests represent the equity in subsidiaries not attributable, directly or indirectly, to the Company. Non-controlling interests are presented in the consolidated statement of financial position and consolidated statement of changes in equity within equity. Non-controlling interests are presented in the consolidated statement of profit or loss and consolidated statement of profit or loss and other comprehensive income as an allocation of profit or loss and total comprehensive income for the year between the non-controlling shareholders and owners of the Company.

Profit or loss and each component of other comprehensive income are attributed to the owners of the Company and to the non-controlling shareholders even if this results in the non-controlling interests having a deficit balance.

Changes in the Company's ownership interest in a subsidiary that do not result in a loss of control are accounted for as equity transactions (i.e. transactions with owners in their capacity as owners). The carrying amounts of the controlling and non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiary. Any difference between the amount by which the non-controlling interests are adjusted and the fair value of the consideration paid or received is recognised directly in equity and attributed to the owners of the Company.

集團內公司間交易、結餘、未變現溢利均予以撇除。未變現虧損亦予以撇除，除非該交易提供所轉讓資產減值的憑據。附屬公司的會計政策於必要時改變，以確保符合本集團採用的會計政策。

非控股權益指並非直接或間接歸屬本公司之附屬公司權益。非控股權益於綜合財務狀況表及綜合權益變動表之權益內列賬。於綜合損益表及綜合損益及其他全面收益表內，非控股權益呈列為年內損益及全面收益總額在非控股股東與本公司擁有人之間的分配。

損益及其他全面收益之各個組成部份歸屬於本公司之擁有人及非控股股東，即使此舉會導致非控股權益有虧絀結餘。

本公司於附屬公司擁有權益變動(並不導致失去控制權)列作權益交易(即與擁有人以彼等作為擁有人的身份進行的交易)入賬。控股及非控股權益的賬面值將予以調整，以反映其於附屬公司的相對權益變動。非控股權益之調整金額與所付或所收代價的公平值之間的任何差額直接於權益中確認，並歸屬於本公司擁有人。

(b) Separate financial statements

In the Company's statement of financial position, an investment in a subsidiary is stated at cost less impairment loss, unless the investment is classified as held for sale (or included in a disposal group that is classified as held for sale). Cost includes direct attributable costs of investments. The results of subsidiaries are accounted for by the Company on the basis of dividend received or receivable.

Impairment testing of the investments in subsidiaries is required upon receiving a dividend from these investments if the dividend exceeds the total comprehensive income of the subsidiary in the period the dividend is declared or if the carrying amount of the investment in the separate financial statements exceeds the carrying amount in the consolidated financial statements of the investee's net assets including goodwill.

(c) Foreign currency translation

(i) Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "**functional currency**"). The consolidated financial statements are presented in Hong Kong dollars ("**HK\$**"), which is the Company's functional and presentation currency.

(ii) Transactions and balances in each entity's financial statements

Transactions in foreign currencies are translated into the functional currency on initial recognition using the exchange rates prevailing on the transaction dates. Monetary assets and liabilities in foreign currencies are translated at the exchange rates at the end of each reporting period. Gains and losses resulting from this translation policy are recognised in profit or loss.

Non-monetary assets and liabilities that are measured in terms of historical cost in a foreign currency are translated using the foreign exchange rates ruling at the transaction dates. The transaction date is the date on which the company initially recognises such non-monetary assets or liabilities. Non-monetary items that are measured at fair values in foreign currencies are translated using the exchange rates at the dates when the fair values are determined.

於收到該等投資的股息後,如股息超過附屬公司於宣派股息期間的綜合收入總額或如投資於獨立財務報表的賬面值超過投資方資產淨值(包括商譽)於綜合財務報表的賬面金額,則須對該等投資進行減值測試。

(c) 外幣換算

(i) 功能及呈列貨幣

本集團各實體的財務報表內所包括項目,均利用該實體經營的主要經濟環境的貨幣(「**功能貨幣**」)計量。綜合財務報表以港元(「**港元**」)呈列,港元為本公司之功能及呈列貨幣。

(ii) 各實體之財務報表中的交易及結餘

外幣交易於初步確認時均按交易日期的現行匯率換算為功能貨幣。外幣貨幣資產及負債按各報告期末的匯率換算。匯兌政策產生的收益及虧損於損益內確認。

以外幣列值並以歷史成本計量的非貨幣資產及負債乃使用於交易日期適用的外幣匯率換算。交易日期為本公司首次確認相關非貨幣資產或負債的日期。按公平值計量及以外幣計值的非貨幣項目乃按釐定公平值當日的匯率折算。

When a gain or loss on a non-monetary item is recognised in other comprehensive income, any exchange component of that gain or loss is recognised in other comprehensive income. When a gain or loss on a non-monetary item is recognised in profit or loss, any exchange component of that gain or loss is recognised in profit or loss.

(iii) Translation on consolidation

The results and financial position of all the Group entities that have a functional currency different from the Company's presentation currency are translated into the Company's presentation currency as follows:

- Assets and liabilities for each statement of financial position presented are translated at the closing rate at the date of that statement of financial position;
- Income and expenses for each statement of profit or loss and other comprehensive income are translated at average exchange rates for the period (unless this average is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the exchange rates on the transaction dates); and
- All resulting exchange differences are recognised other comprehensive income and accumulated in the foreign currency translation reserve.

On consolidation, exchange differences arising from the translation of monetary items that form part of the net investment in foreign entities are recognised in other comprehensive income and accumulated in the foreign currency translation reserve. When a foreign operation is sold, such exchange differences are reclassified to the consolidated profit or loss as part of the gain or loss on disposal.

Goodwill and fair value adjustments arising on the acquisition of a foreign entity are treated as assets and liabilities of the foreign entity and translated at the closing rate.

所用功能貨幣與本公司呈列貨幣不同的所有本集團旗下各實體的業績及財務狀況均按下列方式換算為本公司的呈列貨幣：

- 各財務狀況表所列資產及負債均於該財務狀況表日期按收市匯率換算；
- 各損益及其他全面收益表的收入及開支均按期內平均匯率換算(除非該平均數並非交易日期的現行匯率累計影響的合理約數，則在此情況下收入及開支按交易日期的匯率換算)；及
- 所有產生的匯兌差額均確認為其他全面收益並在外幣換算儲備中累計。

綜合入賬時，因換算海外實體投資淨額的貨幣項目產生的匯兌差額於其他全面收益確認及累計於外幣換算儲備。當出售海外業務時，有關的匯兌差額於綜合損益中重新分類為出售收益或虧損的一部分。

於收購海外實體產生之商譽及公平值調整被視為海外實體的資產及負債，並按收市匯率換算。

(d) Property, plant and equipment

Property, plant and equipment are stated at cost less accumulated depreciation and impairment losses. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other repairs and maintenance are recognised in the profit or loss during the period in which they are incurred.

Depreciation of property, plant and equipment is calculated at rates sufficient to write off their costs less their residual values over the estimated useful lives on a straight-line basis. The principal annual rates used for this purpose are as follows:

Furniture and fixtures	20%
Biometric identification devices	20%
Motor vehicles	30%
Computer equipment	20%
Leasehold improvement	20%

The residual values, useful lives and depreciation method are reviewed and adjusted, if appropriate, at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. The gain or loss on disposal of property, plant and equipment is the difference between the net sales proceeds and the carrying amount of the relevant asset, and is recognised in profit or loss in the year in which the item is derecognised.

僅當與項目相關的未來經濟利益將會流入本集團，且項目的成本能夠可靠計量時，其後成本方會計入資產賬面值或確認為一項獨立資產(倘適用)。所有其他維修及保養成本於其產生的期間在損益內確認。

物業、廠房及設備折舊乃於其估計可使用年期按足以撇銷其成本減剩餘價值的比率以直線法計算。就此所採用之主要年率如下：

(e) Intangible assets (other than goodwill)

Intangible assets acquired are measured on initial recognition at cost. The useful lives of intangible assets are assessed to be whether finite or indefinite. Intangible assets with finite lives are subsequently amortised over the useful economic life and assessed for impairment whenever there is an indication that the intangible asset may be impaired. The amortisation period and the amortisation method for an intangible asset with a finite useful life are reviewed at the end of each reporting period.

Expenditure incurred on projects to develop new products is capitalised and deferred only when the Group can demonstrate the technical feasibility of completing the intangible asset so that it will be available for use or sale, its intention to complete and its ability to use or sell the asset, how the asset will generate future economic benefits, the availability of resources to complete the project and the ability to measure reliably the expenditure during the development. Product development expenditure which does not meet these criteria is expensed when incurred. With respect to staff costs incurred directly attributable to solution service income, it will be regarded as cost of sales and charged to profit or loss of the Group accordingly.

Software development costs are stated at cost less any impairment losses and are amortised using the straight-line basis over the commercial lives of the underlying products not exceeding five years, commencing from the date when the software are put into commercial production.

購入的無形資產於初步確認時按成本計量。無形資產的可使用年期評估為有限或無限。年期有限的無形資產隨後於可使用經濟年內攤銷，並評估是否有跡象顯示無形資產可能出現減值。可使用年期有限的無形資產的攤銷年期及攤銷方法於各報告期末檢討。

研發新產品項目所產生的開支只會在本集團能夠顯示其在技術上能夠完成無形資產以能供使用或出售、打算完成資產並能夠加以使用或將之出售、資產如何產生未來經濟利益、有足夠資源以完成項目並且有能力可靠地計算發展期間的開支的情況下，才會撥作資本及遞延。倘未能符合以上準則，產品研發開支會在產生時支銷。就解決方案服務直接產生的員工成本而言，其將被視為銷售成本，並據此計入本集團的損益。

軟件開發成本按成本減任何減值虧損列賬，並以直線法在相關產品不超過其經濟可用年期的五年(自其投產日期起計)內攤銷。

(f) Leases

At inception of a contract, the Group assesses whether the contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. Control is conveyed where the customer has both the right to direct the use of the identified asset and to obtain substantially all of the economic benefits from that use.

The Group as a lessee

Where the contract contains lease component(s) and non-lease component(s), the Group has elected not to separate non-lease components and accounts for each lease component and any associated non-lease components as a single lease component for all leases.

At the lease commencement date, the Group recognises a right-of-use asset and a lease liability, except for short-term leases that have a lease term of 12 months or less and leases of low-value assets, which for the Group are primarily office premises. When the Group enters into a lease in respect of low-value asset, the Group decides whether to capitalise the lease on a lease-by-lease basis. The lease payments associated with those leases which are not capitalised are recognised as an expense on a systematic basis over the lease term.

Where the lease is capitalised, the lease liability is initially recognised at the present value of the lease payments payable over the lease term, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, using a relevant incremental borrowing rate. Lease payments to be made under reasonably certain extension options are also included in the measurement of the lease liability. After initial recognition, the lease liability is measured at amortised cost and interest expense is calculated using the effective interest method. Variable lease payments that do not depend on an index or rate are not included in the measurement of the lease liability and hence are charged to profit or loss in the accounting period in which they are incurred.

於合約開始時，本集團會評估該合約是否為或包含租賃。倘合約為換取代價而給予在一段時間內控制已識別資產使用的權利，則該合約為或包含租賃。倘客戶有權指示已識別資產的使用及從該使用中獲得絕大部分經濟利益，則表示擁有控制權。

本集團作為承租人

倘合約包含租賃部分及非租賃部分，則本集團選擇不區分非租賃部分，並就所有租賃將各租賃部分及任何相關的非租賃部分入賬列為單一租賃部分。

於租賃開始日期，本集團確認使用權資產及租賃負債，惟租賃期為12個月或以下的短期租賃及低價值資產（就本集團而言主要為辦公場所）租賃則除外。當本集團就低價值資產訂立租賃，則本集團決定是否按個別租賃基準將租賃資本化。與該等尚未資本化的租賃有關的租賃付款於租賃期內按系統化基準確認為開支。

倘租賃已資本化，則租賃負債初步於租賃期內按應付租賃付款的現值確認，並使用租賃中隱含的利率進行貼現，或倘該利率無法輕易釐定，則使用相關增量借款利率。將於合理確定的延期選項下作出的租賃付款亦包括在租賃負債的計量中。於初步確認後，租賃負債按攤銷成本計量，而利息開支則使用實際利率法計算。不取決於指數或利率的可變租賃付款並不計入租賃負債的計量，故於其產生的會計期間自損益扣除。

To determine the incremental borrowing rate, the Group:

- where possible, uses recent third-party financing received by the individual lessee as a starting point, adjusted to reflect changes in financing conditions since third party financing was received
- uses a build-up approach that starts with a risk-free interest rate adjusted for credit risk for leases held by the group entities, which do not have recent third-party financing, and
- makes adjustments specific to the lease, e.g. term, country, currency and security.

If a readily observable amortising loan rate is available to the individual lessee (through recent financing or market data) which has a similar payment profile to the lease, then the group entities use that rate as a starting point to determine the incremental borrowing rate.

The right-of-use asset recognised when a lease is capitalised is initially measured at cost, which comprises the initial amount of the lease liability plus any lease payments made at or before the commencement date, and any initial direct costs incurred. Where applicable, the cost of the right-of-use assets also includes an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located, discounted to their present value, less any lease incentives received. The right-of-use asset is subsequently stated at cost less accumulated depreciation and impairment losses.

Right-of-use assets in which the Group is reasonably certain to obtain ownership of the underlying leased assets at the end of the lease term are depreciated from commencement date to the end of the useful life. Otherwise, right-of-use assets are depreciated on a straight-line basis over the shorter of its estimated useful life and the lease term.

- 對於集團實體所持近期並無第三方融資的租賃，採用建立法，以按信貸風險調整的無風險利率為起點，及
- 對租賃作出具體調整，如期限、國家、貨幣及安全。

如個別承租人可(透過最近融資或市場數據)得到輕易可觀察的攤銷貸款利率(具有與租賃類似的支付情況)，集團實體將該利率用作起點，以釐定增量借款利率。

於租賃資本化時確認的使用權資產初步按成本計量，當中包括租賃負債的初步金額加任何於開始日期或之前作出的租賃付款及所產生的任何初步直接成本。在適用的情況下，使用權資產成本亦包括拆卸及移除相關資產或將相關資產或相關資產所在地復原的成本估計，按其現值貼現並扣減任何已收租賃優惠。使用權資產其後按成本減累計折舊及減值虧損列賬。

本集團合理確定於租賃期結束時獲得相關租賃資產擁有權的使用權資產自開始日期起至可使用年期結束止計提折舊。否則，使用權資產於其估計可使用年期及租賃期兩者中的較短者按直線法計提折舊。

The Group as a lessee (continued)

Refundable rental deposits paid are accounted under HKFRS 9 and initially measured at fair value. Adjustments to fair value at initial recognition are considered as additional lease payments and included in the cost of right-of-use assets.

The lease liability is remeasured when there is a change in future lease payments arising from a change in an index or rate, or there is a change in the Group's estimate of the amount expected to be payable under a residual value guarantee, or there is a change arising from the reassessment of whether the Group will be reasonably certain to exercise a purchase, extension or termination option. When the lease liability is remeasured in this way, a corresponding adjustment is made to the carrying amount of the right-of-use asset, or is recorded in profit or loss if the carrying amount of the right-of-use asset has been reduced to zero.

The lease liability is also remeasured when there is a change in the scope of a lease or the consideration for a lease that is not originally provided for in the lease contract ("**Lease Modification**") that is not accounted for as a separate lease. In this case the lease liability is remeasured based on the revised lease payments and lease term using a revised discount rate at the effective date of the modification. The only exceptions are any rent concessions which arose as a direct consequence of the COVID-19 pandemic and which satisfied the conditions set out in paragraph 46B of HKFRS 16. In such cases, the Group took advantage of the practical expedient set out in paragraph 46A of HKFRS 16 and recognised the change in consideration as if it were not a lease modification.

The Group as a lessor

When the Group acts as a lessor, it determines at lease inception whether each lease is a finance lease or an operating lease. A lease is classified as a finance lease if it transfers substantially all the risks and rewards incidental to the ownership of an underlying assets to the lessee. If this is not the case, the lease is classified as an operating lease.

本集團作為承租人(續)

香港財務報告準則第9號項下入賬的可退回租賃按金初步按公平值計量。初步確認公平值調整被視為額外租賃付款，而計入使用權資產成本。

倘未來租賃付款因指數或利率變動而出現變動，或本集團剩餘價值擔保項下預期應付的金額估計出現變動，或因重新評估本集團是否將合理確定行使購買、延長或終止選擇權而產生變動，則重新計量租賃負債。倘租賃負債以此方式重新計量，則對使用權資產的賬面值作出相應調整，或倘使用權資產的賬面值已調減至零，則於損益內列賬。

當租賃範疇發生變化或租賃合約原先並無規定的租賃代價發生變化(「**租賃修改**」)，且未作為單獨的租賃入賬時，則亦要對租賃負債進行重新計量。在該等情況，租賃負債根據經修訂的租賃付款和租賃期，使用經修訂的貼現率在修改生效日重新計量。唯一的例外是因COVID-19疫情的直接後果而產生及符合香港財務報告準則第16號第46B段所載條件的任何租金寬減。在該等情況下，本集團利用香港財務報告準則第16號第46A段所載的可行權宜方法確認代價變動，猶如其並非租賃修改。

本集團作為出租人

當本集團作為出租人時，本集團於租賃開始時釐定每項租賃是融資租賃還是經營租賃。倘租賃將相關資產所有權相關之絕大部分風險及回報轉讓歸承租人所有，則分類為融資租賃，否則，租賃分類為經營租賃。

(g) Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined using the first-in, first-out basis and comprise all costs of purchase and, where applicable, cost of conversion and other costs that have been incurred in bringing the inventories to their present location and condition. Net realisable value is the estimated selling price in the ordinary course of business, less the estimated costs of completion and the estimated costs necessary to make the sale include incremental costs directly attributable to the sale and non-incremental costs which the Group must incur to make the sale. When inventories are sold, the carrying amount of those inventories is recognised as an expense in the period in which the related revenue is recognised. The amount of any write-down of inventories to net realisable value and all losses of inventories are recognised in the profit or loss in the period of write-down or loss occurs. The amount of any reversal of any write-down of inventories recognised as an increment in the amount of inventories and recognised in the profit or loss in the period in which the reversal occurs.

(h) Contract liabilities

A contract liability is recognised when the customer pays consideration before the Group recognises the related revenue. A contract liability would also be recognised if the Group has an unconditional right to receive consideration before the Group recognises the related revenue. In such cases, a corresponding receivable would also be recognised.

(i) Recognition and derecognition of financial instruments

Financial assets and financial liabilities are recognised in the consolidated statement of financial position when the Group entity becomes a party to the contractual provisions of the instrument.

存貨乃按成本與可變現淨值之較低者入賬。成本採用先入先出基準釐定並包括所有購入成本及(如適用)轉換成本以及其他致使存貨能達到目前位置及狀況之成本。可變現淨值為在日常業務過程中的估計售價減去直至完工的估計成本及為完成銷售所需的估計成本,包括直接用作銷售的增量成本及本集團進行銷售時必須產生的非增量成本。當存貨售出時,該等存貨的賬面值於確認有關收益期間支銷。將存貨撇減至可變現淨值的金額及存貨的所有虧損於撇減或虧損發生期間於損益內確認。任何存貨撇減的撥回金額乃於發生撥回期間在損益內確認為存貨金額增加。

倘客戶於本集團確認相關收益之前支付代價,即確認合約負債。倘本集團擁有無條件權利可於本集團確認相關收益之前收取代價,亦將確認合約負債。在此情況下,亦將確認相應的應收款項。

(i) 確認及終止確認金融工具

金融資產及金融負債於本集團實體成為工具合約條文之訂約方時在綜合財務狀況表確認。

Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit or loss ("FVTPL")) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at FVTPL are recognised immediately in profit or loss.

The Group derecognises a financial asset only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity. If the Group neither transfers nor retains substantially all the risks and rewards of ownership and continues to control the transferred asset, the Group recognises its retained interest in the asset and an associated liability for amounts it may have to pay. If the Group retains substantially all the risks and rewards of ownership of a transferred financial asset, the Group continues to recognise the financial asset and also recognises a collateralised borrowing for the proceeds received.

The Group derecognises financial liabilities when, and only when, the Group's obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable, including any non-cash assets transferred or liabilities assumed, is recognised in profit or loss.

Financial assets and liabilities are offset and the net amount reported in the statement of financial position when there is a legally enforceable right to offset the recognised amounts and there is an intention to settle on a net basis or realise the asset and settle the liability simultaneously. The legally enforceable right must not be contingent on future events and must be enforceable in the normal course of business and in the event of default, insolvency or bankruptcy of the company or the counterparty.

當有法定可執行權利可抵銷已確認金額，並有意按淨額基準結算或同時變現資產及結算負債時，金融資產與負債可互相抵銷，並在財務狀況表報告其淨額。法定可執行權利不得依賴未來事件而定，而在一般業務過程中以及倘公司或對手方一旦出現違約、無償債能力或破產時亦必須可強制執行。

(i) Financial assets

All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the marketplace. All recognised financial assets are measured subsequently in their entirety at either amortised cost or fair value, depending on the classification of the financial assets.

Debt investments

Debt investments held by the Group are classified into one of the following measurement categories:

- amortised cost, if the investment is held for the collection of contractual cash flows which represent solely payments of principal and interest. Interest income from the investment is calculated using the effective interest method.
- Fair value through other comprehensive income (“**FVTOCI**”) — recycling, if the contractual cash flows of the investment comprise solely payments of principal and interest and the investment is held within a business model whose objective is achieved by both the collection of contractual cash flows and sale. Changes in fair value are recognised in other comprehensive income, except for the recognition in profit or loss of expected credit losses (“**ECL**”), interest income (calculated using the effective interest method) and foreign exchange gains and losses. When the investment is derecognised, the amount accumulated in other comprehensive income is recycled from equity to profit or loss.
- FVTPL if the investment does not meet the criteria for being measured at amortised cost or FVTOCI (recycling). Changes in the fair value of the investment (including interest) are recognised in profit or loss.

金融資產的所有常規買賣按交易日期基準確認及終止確認。常規買賣指須按市場規定或慣例所定時限內交付資產的金融資產買賣。視乎金融資產的分類，所有已確認金融資產其後按攤銷成本或公平值作整體計量。

債務投資

本集團持有的債務投資分類為以下計量類別之一：

- 攤銷成本，如持有投資是為了收取合約現金流量（即僅支付本金及利息）。投資的利息收入乃採用實際利率法計算。
- 按公平值計入其他全面收益（「**按公平值計入其他全面收益**」）— 可劃轉，倘投資的合約現金流量僅包括本金及利息付款，並且持作投資的目的為同時收回合約現金流量及出售的業務模式。公平值的變動於其他全面收益內確認，惟預期信貸虧損（「**預期信貸虧損**」）、利息收入（採用實際利率法計算）及匯兌收益及虧損於損益內確認。當終止確認該投資時，於其他全面收益內累計的金額由權益轉入損益。

Equity investments

An investment in equity securities is classified as FVTPL unless the equity investment is not held for trading purposes and on initial recognition of the investment the Group makes an election to designate the investment at FVTOCI (non-recycling) such that subsequent changes in fair value are recognised in other comprehensive income. Such elections are made on an instrument-by-instrument basis, but may only be made if the investment meets the definition of equity from the issuer's perspective. Where such an election is made, the amount accumulated in other comprehensive income remains in the fair value reserve (non-recycling) until the investment is disposed of. At the time of disposal, the amount accumulated in the fair value reserve (non-recycling) is transferred to retained earnings. It is not recycled through profit or loss. Dividends from an investment in equity securities, irrespective of whether classified as at FVTPL or FVTOCI, are recognised in profit or loss as other income.

(k) Trade and other receivables

A receivable is recognised when the Group has an unconditional right to receive consideration. A right to receive consideration is unconditional if only the passage of time is required before payment of that consideration is due. If revenue has been recognised before the Group has an unconditional right to receive consideration, the amount is presented as a contract asset.

Trade and other receivables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method less allowance for credit loss.

(l) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition. Bank overdrafts that are repayable on demand and form an integral part of the Group's cash management are also included as a component of cash and cash equivalents for the purpose of the consolidated statement of cash flow. Cash and cash equivalents are assessed for ECL.

股權投資

於股本證券的投資分類為按公平值計入損益，除非股權投資並非持作交易用途，且本集團於初步確認投資時選擇將投資指定為按公平值計入其他全面收益(不可劃轉)，致使公平值其後變動於其他全面收益內確認。該等選擇按個別工具基準作出，惟僅當發行人認為投資符合權益定義的情況下方可作出。倘作出有關選擇，則於其他全面收益內累計的金額仍將保留於公平值儲備(不可劃轉)，直至出售投資為止。於出售時，於公平值儲備(不可劃轉)內累計的金額轉入保留盈利，且不會轉入損益。股本證券投資所得股息(不論分類為按公平值計入損益或按公平值計入其他全面收益)於損益內確認為其他收入。

(k) 貿易及其他應收款項

應收款項於本集團具有無條件權利收取代價時予以確認。倘代價僅隨時間推移即會成為到期應付，則收取代價的權利為無條件。倘收益在本集團具有無條件權利收取代價前經已確認，則金額呈列為合約資產。

貿易及其他應收款項初步按公平值確認，其後按實際利率法以攤銷成本扣除信貸虧損撥備計量。

(l) 現金及現金等價物

現金及現金等價物包括銀行現金及手頭現金、銀行及其他金融機構的活期存款，以及購入時於三個月內到期可隨時兌換為已知金額及存在非重大價值變動風險的短期高流通性投資。須按要求償還並構成本集團現金管理的整體一部分的銀行透支亦於綜合現金流量表入賬列作現金及現金等價物部分。現金及現金等價物的預期信貸虧損已予以評估。

(m) Financial liabilities and equity instruments

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into and the definitions of a financial liability and an equity instrument under HKFRS Accounting Standards. An equity instrument is any contract that evidences a residual interest in the assets of the Group after deducting all of its liabilities. The accounting policies adopted for specific financial liabilities and equity instruments are set out below.

(n) Trade and other payables

Trade and other payables are stated initially at fair value and subsequently measured at amortised cost using the effective interest method unless the effect of discounting would be immaterial, in which case they are stated at cost.

(o) Equity instruments

An equity instrument is any contract that evidence a residual interest in the assets of an entity after deducting all of its liabilities. Equity instruments issued by the Company are recorded at the proceeds received, net of direct issue costs.

(p) Revenue recognition and other income

Revenue is recognised when control over a product or service is transferred to the customer, at the amount of promised consideration to which the Group is expected to be entitled, excluding those amounts collected on behalf of third parties. Revenue excludes value added tax or other sales taxes and is after deduction of any trade discounts.

Revenue from the sale of biometric identification devices, security products and other accessories is recognised when control of the goods has transferred, being when the goods have been delivered to the buyer's specific location (delivery). Under the Group's standard contract terms, customers are entitled to a one-year maintenance. At the point of sale, a contract liability and corresponding adjustment to revenue is recognised, representing the unfulfilled performance obligation of the maintenance services. The contract liability would be recognised as income on a straight-line basis over the warranty period.

Revenue from provision of installation and other services are recognised when the relevant services are rendered and delivered to customers.

(m) 金融負債及權益工具

金融負債及權益工具乃根據所訂立合約安排的内容及香港財務報告準則會計準則項下金融負債和權益工具的定義分類。權益工具乃證明於經扣除其所有負債後顯示本集團資產的剩餘權益的任何合約。下文載列就特定金融負債及權益工具採納的會計政策。

(n) 貿易及其他應付款項

貿易及其他應付款項初步按公平值列賬，其後採用實際利率法按攤銷成本計量，除非貼現影響甚微，於此情況下，則以成本列賬。

(o) 權益工具

權益工具為證明某一實體資產的剩餘權益(扣減其所有負債後)的任何合約。本公司所發行的權益工具按已收所得款項扣除直接發行成本入賬。

(p) 收益確認及其他收入

收益於商品或服務的控制權轉移予客戶時確認，金額為本集團預期有權收取的承諾代價，不包括代第三方收取的金額。收益不含增值稅或其他銷售稅，且已扣減任何買賣折扣。

銷售生物特徵識別裝置、保安產品及其他配件所得收益於商品控制權轉移時(即商品已交付至買方的特定地點(交付))確認。根據本集團的標準合約條款，客戶享有一年免費維護服務。在銷售時，確認合約負債及收益的相應調整，即維護服務的未履行履約責任。合約負債於保修期內按直線法確認為收入。

提供安裝及其他服務所得收益於提供相關服務及向客戶交付相關服務時確認。

(p) Revenue recognition and other income (continued)

Revenue from software licensing, provision of maintenance, management and business solutions services are recognised on a straight-basis over the term of the agreed service period.

Revenue from provision of online information and digital marketing services is performance-based, which allow advertising customers to place links on the third parties' internet platforms. Performance-based digital marketing services are primarily presented and delivered in the way of short video and mobile apps with clickable thumbnails together with other recommended short videos or displayed between other short videos at varying frequency. Revenue from performance-based digital marketing services is recognised when relevant specific performance measures are fulfilled.

Revenue from provision of lifestyle and wellness services is recognised when the services have been provided.

Interest income is recognised as it accrues using the effective interest method. For financial assets measured at amortised cost or FVTOCI (recycling) that are not credit-impaired, the effective interest rate is applied to the gross carrying amount of the asset. For credit impaired financial assets, the effective interest rate is applied to the amortised cost (i.e. gross carrying amount net of loss allowance) of the asset.

(q) Employee benefits

(i) Employee leave entitlements

Employee entitlements to annual leave and long service leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave and long service leave as a result of services rendered by employees up to the end of the reporting period.

Employee entitlements to sick leave and maternity leave are not recognised until the time of leave.

軟件許可、提供維護、管理及業務解決方案服務所得收益於協定的服務期內按直線法確認。

提供網上資訊及數碼營銷服務所得收益屬表現掛鈎性質，允許廣告客戶在第三方互聯網平台上放置鏈接。表現掛鈎的數碼營銷服務主要以短視頻及流動應用程式的方式呈現及交付，並附帶可點擊的縮圖，與其他推薦的短視頻一起展示或以不同頻率在其他短視頻之間顯示。表現掛鈎數碼營銷服務所得收益於相關特定表現指標達成時確認。

提供生活及健康服務所得收益於服務已提供時確認。

利息收入於產生時以實際利率法確認。就按攤銷成本或按公平值計入其他全面收益(可劃轉)計量且並無出現信貸減值的金融資產而言，實際利率適用於該資產的賬面總值。就出現信貸減值的金融資產而言，實際利率應用於該資產的攤銷成本(即扣除虧損撥備的賬面總值)。

(q) 僱員福利

(i) 僱員應享假期

僱員的年假及長期服務假期於僱員應享有時予以確認。截至報告期末，僱員所提供的服務而產生的年假及長期服務假期的估計負債已計提撥備。

僱員的病假及產假於僱員休假時方會確認。

(ii) Pension obligations

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (“**MPF Scheme**”) under the Mandatory Provident Fund Schemes Ordinance (Chapter 485 of the Laws of Hong Kong) for all of its employees in Hong Kong. Contributions are made based on a percentage of the employees’ basic salaries and are charged to the statement of profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group’s employer contributions vest fully with the employees when it made contribution to the MPF Scheme. No forfeited contribution is available to reduce the contribution payable in future years.

For LSP obligation, the Group accounts for the employer MPF contributions expected to be offsetted as a deemed employee contribution towards the LSP obligation in term of HKAS 19 paragraph 93(a) and it is measured on a net basis. The estimated amount of future benefit is determined after deducting the negative service cost arising from the accrued benefits derived from the Group’s MPF contributions that have been vested with employees, which are deemed to be contributions from the relevant employees.

(iii) Termination benefits

Termination benefits are recognised at the earlier of the dates when the Group can no longer withdraw the offer of those benefits and when the Group recognises restructuring costs and involves the payment of termination benefits.

(r) Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets, until such time as the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

(ii) 退休金責任

本集團根據香港法例第485章《強制性公積金計劃條例》為其所有香港僱員營運一項定額供款強制性公積金退休福利計劃(「**強積金計劃**」)。供款乃按僱員基本薪金的百分比作出，並於根據強積金計劃規則須予支付時在損益表中支銷。強積金計劃的資產與本集團的資產分開持有，由獨立管理的基金保管。本集團的僱主供款於向強積金計劃作出供款時即全數歸屬僱員。並無沒收供款可用於減少未來年度的應付供款。

就長期服務金義務而言，本集團根據香港會計準則第19號第93(a)段將預期以視作僱員就長期服務金義務作出的供款的方式抵銷的強積金供款入賬，並按淨額基準計量。估計未來福利金額在扣除本集團強積金供款所產生歸屬僱員的累算福利產生的負服務成本後釐定，有關供款被視為相關僱員的供款。

(iii) 離職福利

離職福利於本集團再無能力撤銷提供該等福利時或本集團確認重組成本並涉及支付離職福利時(以較早者為準)確認。

(r) 借款成本

直接用作購入、建造或生產合資格資產(即需要相當長期間以達致其擬定用途或銷售的資產)的借款成本會資本化作為該等資產的部分成本，直至資產大致準備妥當以用作其擬定用途或銷售。特定用於合資格資產的借款在其尚未支銷時用作短暫投資所賺取的投資收入，乃於合資格資本化的借款成本內扣除。

(r) Borrowing costs (continued)

To the extent that funds are borrowed generally and used for the purpose of obtaining a qualifying asset, the amount of borrowing costs eligible for capitalisation is determined by applying a capitalisation rate to the expenditures on that asset. The capitalisation rate is the weighted average of the borrowing costs applicable to the borrowings of the Group that are outstanding during the period, other than borrowings made specifically for the purpose of obtaining a qualifying asset.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

(s) Government grants

Government grants are recognised when there is reasonable assurance that the Group will comply with the conditions attaching to it and that the grant will be received.

Grants that compensate the Group for expenses incurred are recognised as income in profit or loss on a systematic basis in the same periods in which the expenses are incurred.

(t) Taxation

Income tax represents the sum of the current tax and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit recognised in profit or loss because it excludes items of income or expense that are taxable or deductible in other years and it further excludes items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

倘一般性借入資金用於獲取一項合資格資產，合資格資本化的借款成本金額乃按該資產支銷的資本化率釐定。資本化率為適用於本集團於期內未償還借款的加權平均借款成本，不包括為取得合資格資產而專門借入的借款。

所有其他借款成本均於產生期間於損益內確認。

(s) 政府補助

當有合理保證本集團將遵守其所附條件且將收到該政府補助時，將確認政府補助。

補償本集團已產生費用的補助在費用產生的同時按系統基準在損益內確認為收入。

(t) 稅項

所得稅指即期稅項及遞延稅項之總額。

即期應付稅項乃根據年內之應課稅溢利計算。應課稅溢利與於損益內確認的溢利有所不同，乃由於其不包括其他年度的應課稅或可扣減收入或開支項目，且其亦不包括毋須課稅或不可扣減項目。本集團有關即期稅項之負債乃採用於報告期末已實行或實質已實行之稅率計算。

Deferred tax is recognised on differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences and deferred tax assets are recognised to the extent that it is probable that taxable profits will be available against which deductible temporary differences, unused tax losses or unused tax credits can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax is calculated at the tax rates that are expected to apply in the period when the liability is settled or the asset is realised, based on tax rates that have been enacted or substantively enacted by the end of the reporting period. Deferred tax is recognised in profit or loss, except when it relates to items recognised in other comprehensive income or directly in equity, in which case the deferred tax is also recognised in other comprehensive income or directly in equity.

The measurement of deferred tax assets and liabilities reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied by the same taxation authority and the Group intends to settle its current tax assets and liabilities on a net basis.

遞延稅項乃指在綜合財務報表內資產及負債之賬面值與採用應課稅溢利計算之相應稅基之差額。遞延稅項負債一般按所有應課稅暫時差額確認入賬，而遞延稅項資產則會在預期應課稅溢利可供作抵銷可予扣減暫時差額、未動用稅項虧損或未動用稅項抵免時確認入賬。倘暫時差額乃因商譽或首次確認不影響應課稅溢利或會計溢利之交易(業務合併除外)中之其他資產及負債而產生，則不會確認有關資產及負債。

於附屬公司之投資而產生之應課稅暫時差額確認為遞延稅項負債，惟倘本集團可控制暫時差額之撥回，並預期該暫時差額將不會在可見將來撥回者除外。

遞延稅項資產之賬面值乃於各報告期末進行檢討，並調低至預期將不可能有充裕之應課稅溢利以收回所有或部分資產。

遞延稅項乃根據於報告期末已實行或實質實行之稅率，按預期在負債償還或資產變現期間適用之稅率計算。遞延稅項乃自損益中確認，惟倘遞延稅項相關之項目於其他全面收益確認或直接於權益確認時，則在此情況下亦會於其他全面收益或直接於權益確認。

遞延稅項資產及負債之計量反映按照本集團預期於報告期末可收回或結算其資產及負債之賬面值而得出之稅務結果。

當存在法律上可強制執行權利以將即期稅項資產與即期稅項負債抵銷，並且當涉及與同一稅務機關所徵收之所得稅有關且本集團擬按淨額基準結算其即期稅項資產及負債時，則遞延稅項資產及負債可互相對銷。

(u) Impairment of non-financial assets

The carrying amounts of non-financial assets are reviewed at each reporting date for indications of impairment and where an asset is impaired, it is written down as an expense through the consolidated statement of profit or loss to its estimated recoverable amount. The recoverable amount is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets. If this is the case, recoverable amount is determined for the cash-generating unit (“CGU”) to which the asset belongs. Recoverable amount is the higher of value in use and the fair value less costs of disposal of the individual asset or the CGU.

Value in use is the present value of the estimated future cash flows of the asset/CGU. Present values are computed using pre-tax discount rates that reflect the time value of money and the risks specific to the asset/CGU whose impairment is being measured.

Impairment losses for CGU are allocated first against the goodwill of the unit and then pro rata amongst the other assets of the CGU. Subsequent increases in the recoverable amount caused by changes in estimates are credited to profit or loss to the extent that they reverse the impairment.

(v) Impairment of financial assets

The Group recognises a loss allowance for ECL measured at amortised cost such as trade receivables. The amount of ECL is updated at each reporting date to reflect changes in credit risk since initial recognition of the respective financial instrument.

The Group always recognises lifetime ECL for trade receivables. The ECL on these financial assets are estimated using a provision matrix based on the Group’s historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current as well as the forecast direction of conditions at the reporting date, including time value of money where appropriate.

非金融資產的賬面值於各報告日期進行檢討，以檢視是否有跡象發生減值，如果資產發生減值，則通過綜合損益表將其撇減至其估計可收回金額，撇減金額為開支。可收回金額按個別資產釐定，除非該資產不能產出基本上獨立於其他資產或資產組所產生的現金流入。在這種情況下，可確定該資產所屬的現金產生單位（「現金產生單位」）的可收回金額。可收回金額為個別資產或現金產生單位之使用價值與其公平值減出售成本兩者中之較高者。

使用價值是資產／現金產生單位的估計未來現金流量的現值。現值使用反映貨幣時間價值及資產／現金產生單位（已計量減值）特定風險的稅前貼現率計算。

現金產生單位的減值虧損應當先分配至單位中的商譽，再按比例分配至現金產生單位的其他資產。由於估計變動而導致的其後可收回金額增加按所撥回的減值額計入損益。

(v) 金融資產減值

本集團就按攤銷成本計量的預期信貸虧損確認虧損撥備，例如貿易應收款項。預期信貸虧損的金額於各報告日期予以更新，以反映自初步確認各金融工具以來信貸風險的變動。

本集團一直為貿易應收款項確認全期預期信貸虧損。該等金融資產的預期信貸虧損乃使用根據本集團過往信貸虧損經驗計算的撥備矩陣進行估計，並就債務人的特定因素、整體經濟狀況及對於報告日期的現時狀況及預測狀況動向的評估（於適用情況下包括貨幣的時間價值）作出調整。

For all other financial instruments, the Group recognises lifetime ECL when there has been a significant increase in credit risk since initial recognition. However, if the credit risk on the financial instrument has not increased significantly since initial recognition, the Group measures the loss allowance for that financial instrument at an amount equal to 12-month ECL.

Lifetime ECL represents the ECL that will result from all possible default events over the expected life of a financial instrument. In contrast, 12-month ECL represents the portion of lifetime ECL that is expected to result from default events on a financial instrument that are possible within 12 months after the reporting date.

Significant increase in credit risk

In assessing whether the credit risk on a financial instrument has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial instrument at the reporting date with the risk of a default occurring on the financial instrument at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort. Forward-looking information considered includes the future prospects of the industries in which the Group's debtors operate, obtained from economic expert reports, financial analysts, governmental bodies, relevant think-tanks and other similar organisations, as well as consideration of various external sources of actual and forecast economic information that relate to the Group's core operations.

就所有其他金融工具而言，倘自初步確認以來信貸風險已顯著增加，則本集團確認全期預期信貸虧損。然而，倘自初步確認以來金融工具的信貸風險並無顯著增加，則本集團按與12個月預期信貸虧損的等額計算有關金融工具的虧損撥備。

全期預期信貸虧損指於金融工具預期壽命內發生所有可能的違約事件而導致的預期信貸虧損。相反，12個月預期信貸虧損則指預期於報告日期後12個月內可能發生的金融工具違約事件而導致的部分全期預期信貸虧損。

信貸風險顯著增加

為評估金融工具的信貸風險自初步確認以來是否已顯著增加，本集團會將金融工具於報告日期出現違約的風險與該金融工具於初步確認日期出現違約的風險比較。本集團進行此評估時，會考慮合理及有依據的量化及質性資料，包括參考過往經驗及無須耗費不必要的成本或精力而取得的前瞻性資料。納入考量的前瞻性資料包括來自經濟專家報告、金融分析師、政府機構、相關智庫及其他類似機構所觀望本集團債務人所經營行業的未來前景，以及考慮與本集團主要業務相關的實際及預測經濟資料的不同外部來源。

In particular, the following information is taken into account when assessing whether credit risk has increased significantly since initial recognition:

- an actual or expected significant deterioration in the financial instrument's external (if available) or internal credit rating;
- significant deterioration in external market indicators of credit risk for a particular financial instrument;
- existing or forecast adverse changes in business, financial or economic conditions that are expected to cause a significant decrease in the debtor's ability to meet its debt obligations;
- an actual or expected significant deterioration in the operating results of the debtor;
- significant increases in credit risk on other financial instruments of the same debtor;
- an actual or expected significant adverse change in the regulatory, economic, or technological environment of the debtor that results in a significant decrease in the debtor's ability to meet its debt obligations.

Irrespective of the outcome of the above assessment, the Group presumes that the credit risk on a financial asset has increased significantly since initial recognition when contractual payments are more than 30 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

信貸風險顯著增加(續)

具體而言，評估信貸風險是否自初步確認以來已顯著增加時會考慮以下資料：

- 金融工具的外部(如有)或內部信貸評級的實際或預期嚴重惡化；
- 具體金融工具的信貸風險的外部市場指標嚴重轉差；
- 業務、金融或經濟環境目前出現或預期出現不利變動，並預期使債務人的債務償還能力嚴重下降；
- 債務人的經營業績實際上或預期嚴重惡化；
- 有關相同債務人的其他金融工具的信貸風險顯著增加；
- 債務人面對的監管、經濟或技術環境在實際上或預計會發生重大不利變動，導致債務人的債務償還能力嚴重下降。

不論上述評估結果，本集團認為，當合約付款逾期超過30日，則自初步確認以來金融資產的信貸風險已顯著增加，除非本集團有合理及有依據的資料證明則當別論。

Despite the foregoing, the Group assumes that the credit risk on a financial instrument has not increased significantly since initial recognition if the financial instrument is determined to have low credit risk at the reporting date. A financial instrument is determined to have low credit risk if:

- (i) The financial instrument has a low risk of default,
- (ii) The debtor has a strong capacity to meet its contractual cash flow obligations in the near term, and
- (iii) Adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfil its contractual cash flow obligations.

The Group considers a financial asset to have low credit risk when the asset has external credit rating of “investment grade” in accordance with the globally understood definition or if an external rating is not available, the asset has an internal rating of “performing”. Performing means that the counterparty has a strong financial position and there is no past due amounts.

The Group regularly monitors the effectiveness of the criteria used to identify whether there has been a significant increase in credit risk and revises them as appropriate to ensure that the criteria are capable of identifying significant increase in credit risk before the amount becomes past due.

Definition of default

The Group considers the following as constituting an event of default for internal credit risk management purposes as historical experience indicates that receivables that meet either of the following criteria are generally not recoverable.

- when there is a breach of financial covenants by the counterparty; or
- information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collaterals held by the Group).

信貸風險顯著增加(續)

儘管如此，本集團假設倘若金融工具於報告日期被確定為具有低信貸風險，則自初步確認以來金融工具的信貸風險則尚未顯著增加。倘若出現以下情況，則金融工具可被確定為具有低信貸風險：

- (i) 金融工具的違約風險較低；
- (ii) 債務人於近期內履行合約現金流量責任的能力強；及
- (iii) 經濟及商業環境的不利變動從長遠來看，可能但不一定會降低借款人履行合約現金流量責任的能力。

本集團認為，倘金融資產具有按照環球理解定義的「投資級別」的外部信貸評級，則有關資產具有低信貸風險，或倘並無外部評級可用，則有關資產具有「良好」的內部評級。良好指對手方財務狀況強固，且並無逾期款項。

本集團定期監察用於識別信貸風險是否有顯著增加的標準的有效性，並對其作出適當修訂，以確保該等標準能於款項逾期前識別信貸風險是否有顯著增加。

違約的定義

本集團認為，就內部信貸風險管理而言，以下事件構成違約事件，原因為過往經驗顯示符合以下任何標準的應收款項一般無法收回。

- 對手方違反財務契諾時；或
- 內部產生或外部來源資料顯示，債務人很可能無法向債權人(包括本集團)悉數還款(不計及本集團所持有任何抵押品)。

Definition of default (continued)

Irrespective of the above analysis, the Group considers that default has occurred when a financial asset is more than 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

Credit-impaired financial assets

A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired includes observable data about the following events:

- significant financial difficulty of the issuer or the counterparty;
- a breach of contract, such as a default or past due event;
- the lender(s) of the counterparty, for economic or contractual reasons relating to the counterparty's financial difficulty, having granted to the counterparty a concession(s) that the lender(s) would not otherwise consider;
- it is becoming probable that the counterparty will enter bankruptcy or other financial reorganisation; or
- the disappearance of an active market for that financial asset because of financial difficulties.

Write-off policy

The Group writes off a financial asset when there is information indicating that the debtor is in severe financial difficulty and there is no realistic prospect of recovery, including when the debtor has been placed under liquidation or has entered into bankruptcy proceedings, or in the case of trade receivables, when the amounts are over two years past due, whichever occurs sooner. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. Any recoveries made are recognised in profit or loss.

不論上文分析，本集團認為，倘金融資產逾期超過90日，則違約已經發生，除非本集團擁有合理及有依據資料顯示一項更滯後的違約標準更為合適則當別論。

出現信貸減值的金融資產

如一項或多項事件發生，導致金融資產的估計未來現金流量受到負面影響，則金融資產出現信貸減值。金融資產出現信貸減值的證據包括有關以下事件的可觀察數據：

- 發行人或對手方出現嚴重財務困難；
- 違約，例如違約或拖欠事件；
- 對手方的貸款人因與對手方出現財務困難相關經濟或合約理由授予對手方貸款人一般不會另行考慮的寬免；
- 對手方很可能將會破產或進行其他財務重組；或
- 有關金融資產的活躍市場因財務困難而消失。

撇銷政策

如有資料顯示債務人出現嚴重財務困難且並無實際收回前景(包括債務人被清盤或已進入破產程序，或如屬貿易應收款項，有關款項逾期超過兩年(以較早發生者為準))，則本集團撇銷該金融資產。已撇銷金融資產仍可面臨本集團收回款項程序的強制執行活動，包括尋求法律意見(如適用)。任何收回款項於損益確認。

Measurement and recognition of ECL

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data adjusted by forward-looking information as described above. As for the exposure at default, for financial assets, this is represented by the assets' gross carrying amount at the reporting date; for financial guarantee contracts, the exposure includes the amount drawn down as at the reporting date, together with any additional amounts expected to be drawn down in the future by default date determined based on historical trend, the Group's understanding of the specific future financing needs of the debtors, and other relevant forward-looking information.

For financial assets, the ECL is estimated as the difference between all contractual cash flows that are due to the Group in accordance with the contract and all the cash flows that the Group expects to receive, discounted at the original effective interest rate.

If the Group has measured the loss allowance for a financial instrument at an amount equal to lifetime ECL in the previous reporting period, but determines at the current reporting date that the conditions for lifetime ECL are no longer met, the Group measures the loss allowance at an amount equal to 12-month ECL at the current reporting date, except for assets for which simplified approach was used.

The Group recognises an impairment gain or loss in profit or loss for all financial instruments with a corresponding adjustment to their carrying amount through a loss allowance account.

預期信貸虧損的計量及確認

預期信貸虧損的計量是違約概率、違約損失(即倘發生違約時的損失程度)及違約風險的函數。違約概率及違約損失的評估基於如上述前瞻性資料調整的過往數據。對於違約風險，就金融資產而言，指為於報告日期的資產賬面總值；就財務擔保合約而言，風險承擔包括於報告日期提取的金額，以及根據過往趨勢、本集團對債務人特定未來融資需求的理解及其他相關前瞻性資料所釐定的違約日期前預期將於未來提取的任何額外金額。

就金融資產而言，預期信貸虧損乃按根據合約應付本集團的所有合約現金流量與本集團預期收取的所有現金流量之間的差額進行估算，並按初始實際利率貼現。

倘本集團已於過往報告期間就一項金融工具按與全期預期信貸虧損相等金額計算虧損撥備，惟於現行報告日期釐定該金融工具不再符合全期預期信貸虧損的條件，則本集團於現行報告日期按與12個月預期信貸虧損相等金額計算虧損撥備，惟使用簡化法的資產除外。

本集團就所有金融工具於損益確認減值收益或虧損，並透過虧損撥備賬對其賬面值進行相應調整。

(w) Provisions and contingent liabilities

Provisions are recognised for liabilities of uncertain timing or amount when the Group has a present legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditures expected to settle the obligation. The discount rate used to determine the present value is a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the liability. The increase in the provision due to the passage of time is recognised as interest expense.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow is remote.

(x) Events after the reporting period

Events after the reporting period that provide additional information about the Group's position at the end of the reporting period or those that indicate the going concern assumption is not appropriate are adjusting events and are reflected in the consolidated financial statements. Events after the reporting period that are not adjusting events are disclosed in the notes to the consolidated financial statements when material.

5. CRITICAL JUDGEMENTS AND KEY ESTIMATES

In the application of the Group's accounting policies, which are described in note 4, the directors of the Company are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and underlying assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

(w) 撥備及或然負債

當本集團因過去事件而承擔現時的法律或推定責任，且可能需流出經濟利益以解除該責任，並能作出可靠估計時，即就時間或金額不確定的負債確認撥備。倘貨幣之時間價值為重要因素，則撥備乃按預期用於解除該責任之支出之現值列賬。用於釐定現值的貼現率為稅前利率，反映當前市場對貨幣時間價值的評估及負債的具體風險。因時間推移而增加的撥備獲確認為利息開支。

倘經濟利益流出的機會不大，或其金額無法可靠估計，則責任乃披露為或然負債，除非經濟利益流出之可能性極低則當別論。可能存在的責任（其存在僅能透過一項或多項未來事件的發生或不發生予以確認），除非流出的可能性極低，否則亦會披露為或然負債。

(x) 報告期後事項

為本集團於報告期末之狀況提供額外資料或顯示持續經營假設並不適合之報告期後事項均屬於調整事項，並於綜合財務報表內反映。並非調整事項之重大報告期後事項則於綜合財務報表附註中披露。

Key sources of estimation uncertainty

The key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are discussed below.

- (i) *Impairment loss for property, plant and equipment, right-of-use assets and intangible assets (other than goodwill)*
- Property, plant and equipment, right-of-use assets and intangible assets are stated at costs less accumulated depreciation and impairment, if any. In determining whether an asset is impaired, the Group has to exercise judgment and make estimation, particularly in assessing: (1) whether an event has occurred or any indicators that may affect the asset value; (2) whether the carrying value of an asset can be supported by the recoverable amount, in the case of value in use, the net present value of future cash flows which are estimated based upon the continued use of the asset; and (3) the appropriate key assumptions to be applied in estimating the recoverable amounts including cash flow projections and an appropriate discount rate. When it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash-generating unit to which the assets belongs. Changing the assumptions and estimates, including the discount rates or the growth rate in the cash flow projections, could materially affect the net present value used in the impairment test.

The carrying amount of property, plant and equipment and right-of-use assets as at 31 March 2026 were approximately HK\$1,203,000 (2025: HK\$269,000) and HK\$4,298,000 (2025: HK\$Nil) respectively. Intangible assets was fully impaired at 31 March 2026 and 2025.

During the year, impairment loss of approximately HK\$910,000 (2025: HK\$114,000) and HK\$3,368,000 (2025: HK\$1,568,000) were recognised to profit or loss in respect of property, plant and equipment and right-of-use assets respectively.

- 物業、廠房及設備、使用權資產及無形資產按成本減累計折舊及減值(如有)列賬。於釐定資產是否減值時，本集團須進行判斷及估計，尤其評估：(1)是否有事件已發生或有任何指標可能影響資產價值；(2)資產賬面值是否能夠以可收回金額支持，如為使用價值，即按照持續使用資產估計的未來現金流量的淨現值；及(3)將應用於估計可收回金額的適當關鍵假設(包括現金流量預測及適當的貼現率)。當無法估計個別資產的可收回金額時，本集團估計資產所屬現金產生單位的可收回金額。更改假設及估計，包括於現金流量預測內的貼現率或增長率，均可能嚴重影響減值測試所採用淨現值。

於2026年3月31日，物業、廠房及設備以及使用權資產的賬面值分別約為1,203,000港元(2025年：269,000港元)及4,298,000港元(2025年：零港元)。無形資產於2026年及2025年3月31日悉數減值。

年內，分別就物業、廠房及設備以及使用權資產確認減值虧損約910,000港元(2025年：114,000港元)及3,368,000港元(2025年：1,568,000港元)至損益。

(ii) Allowance for inventories

Allowance for inventories is made based on the ageing, change in the market conditions and estimated net realisable value of inventories. The assessment of the allowance amount involves judgement and estimates. Where the actual outcome in future is different from the original estimate, such difference will impact the carrying value of inventories and allowance charge/write-back in the period in which such estimate has been changed.

As at 31 March 2026, the carrying amount of inventories was approximately HK\$19,486,000 (2025: HK\$19,310,000).

During the year, a reversal of allowance for inventories of approximately HK\$387,000 (2025: HK\$874,000) was credited to profit or loss.

(iii) Impairment of trade receivables

The management of the Group estimates the amount of impairment loss of trade receivables under ECL model based on the credit risk of trade receivables. The amount of the impairment loss based on ECL model is measured as the difference between all contractual cash flows that are due to the Group in accordance with the contract and all the cash flows that the Group expects to receive, discounted at the effective interest rate determined at initial recognition. Where the future cash flows are less than expected, or being revised downward due to changes in facts and circumstances, a material impairment loss may arise.

As at 31 March 2026, the carrying amount of trade receivables was approximately HK\$10,545,000 (2025: HK\$18,762,000), net of allowance for impairment under ECL of approximately HK\$336,000 (2025: HK\$985,000).

(ii) 存貨撥備

存貨撥備乃基於賬齡、市況變動及存貨的估計可變現淨值作出。評估撥備金額涉及判斷及估計。倘日後實際結果與原有估計不同，有關差異將影響發生有關估計變更的期內存貨及撥備扣減／撥回之賬面值。

於2026年3月31日，存貨的賬面值約為19,486,000港元(2025年：19,310,000港元)。

年內，存貨撥備撥回約387,000港元(2025年：874,000港元)已計入損益。

(iii) 貿易應收款項減值

本集團管理層乃根據貿易應收款項的信貨風險估計預期信貸虧損模式下貿易應收款項的減值虧損金額。基於預期信貸虧損模式的減值虧損金額乃按根據合約應付本集團的所有合約現金流量與本集團預期收取的所有現金流量之間的差額計量，並按初步確認時釐定的實際利率貼現。倘未來現金流量少於預期，或因事實及情況變動而需下調，則可能產生重大減值虧損。

於2026年3月31日，貿易應收款項的賬面值約為10,545,000港元(2025年：18,762,000港元)，經扣除預期信貸虧損的減值撥備約336,000港元(2025年：985,000港元)。

(iv) Actuarial assumptions on defined benefit retirement plans

Accounting for defined benefit plans may be complex because actuarial assumptions are required to measure the obligation and the expense, with the possibility that actual results differ from the assumed results. These differences are known as actuarial gains and losses. Defined benefit obligations are measured using the Projected Unit Credit Method (PUCM), according to which the Group has to make a reliable estimate of the amount of benefits earned in return for services rendered in current and prior periods, using actuarial techniques. In addition, in cases where defined benefit plans are funded, the Group has to estimate the fair value of plan assets. As a result, the use of the PUCM involves a number of actuarial assumptions. These assumptions include demographic assumptions such as mortality, turnover and retirement age and financial assumptions such as discount rates, salary and benefit levels. Such assumptions are subject to judgements and may develop materially differently than expected and therefore may result in significant impacts on defined benefit obligations.

The carrying amount of retirement benefit obligations as at 31 March 2026 was HK\$463,000 (2025: HK\$373,000).

6. FINANCIAL RISK MANAGEMENT

The Group's activities expose it to a variety of financial risks: foreign currency risk, credit risk, interest rate risk and liquidity risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

(a) Foreign currency risk

The functional currency of the Group's entities are principally denominated in HK\$, Renminbi ("RMB"), Macau Pataca ("MOP") and Great British Pound ("GBP"). The Group has minimal exposure to foreign currency risk as most of its business transactions, assets and liabilities are denominated in the functional currency of respective Group's entities.

The Group currently does not have a foreign currency hedging policy in respect of foreign currency transactions, assets and liabilities. The Group monitors its foreign currency exposure closely and will consider hedging significant foreign currency exposure should the need arise.

(iv) 針對界定福利退休計劃的精算假設

界定福利計劃的會計處理可能較為複雜，因為需要精算假設來衡量義務和開支，實際結果可能與假設結果有所不同。這些差異被稱為精算收益及虧損。界定福利責任按預計單位信貸法(PUCM)計量，根據該方法，本集團必須使用精算技術對當前及過往期間提供服務所賺取的福利金額作出可靠估計。此外，若界定福利計劃有資金撥付，本集團需估計計劃資產的公平值。因此，使用PUCM涉及多項精算假設。這些假設包括人口統計假設，例如死亡率、流動率及退休年齡，以及財務假設，例如貼現率、薪酬及福利水準。此等假設受判斷影響，可能會與預期有重大差異，從而可能對界定福利責任造成重大影響。

於2026年3月31日，退休福利義務的賬面值為463,000港元(2025年：373,000港元)。

6. 財務風險管理

本集團的業務須承受多項財務風險：外幣風險、信貸風險、利率風險及流動資金風險。本集團的整體風險管理計劃專注於金融市場的不可預測性，旨在盡可能減低對本集團財務表現構成的潛在不利影響。

(a) 外幣風險

本集團各實體的功能貨幣主要以港元、人民幣(「人民幣」)、澳門幣(「澳門幣」)及英鎊(「英鎊」)計值。由於本集團的大部分業務交易、資產及負債乃以本集團實體各自的功能貨幣計值，故本集團所承受的外幣風險極微。

本集團目前並無就外幣交易、資產及負債制訂任何外幣對沖政策。本集團密切監察其外幣風險，並於有需要時考慮對沖重大外幣風險。

(b) Credit risk

Credit risk is the risk that a counterparty will not meet its obligations under a financial instrument or customer contract, leading to a financial loss. The Company is exposed to credit risk from its operating activities (primarily trade receivables) and from its financing activities, including deposits with banks, foreign exchange transactions and other financial instruments. The Company's exposure to credit risk arising from cash and cash equivalents is limited because the counterparties are banks and financial institutions with high credit-rating assigned by international credit-rating agencies, for which the Company considers to have low credit risk.

Trade receivables

Customer credit risk is managed by each business unit subject to the Group's established policy, procedures and control relating to customer credit risk management. Individual credit evaluations are performed on all customers requiring credit over a certain amount. These evaluations focus on the customer's past history of making payments when due and current ability to pay, and take into account information specific to the customer as well as pertaining to the economic environment in which the customer operates. Trade receivables are due within 30 to 90 days from the date of billing. Debtors with balances that are more than 1 month past due are requested to settle all outstanding balances before any further credit is granted. Normally, the Group does not obtain collateral or other credit enhancements from customers.

The Group has limited concentration of credit risk as it has a large number of customers.

The Group does not provide any guarantees which would expose the Group to credit risk.

The Group measures loss allowances for trade receivable at an amount equal to lifetime ECL, which is calculated using a provision matrix. As the Group's historical credit loss experience does not indicate significantly different loss patterns for different customer segments, the loss allowance based on past due status is not further distinguished between the Group's different customer bases.

信貸風險指對手方未能履行其於金融工具或客戶合約項下的責任而導致財務損失的風險。本集團的信貸風險源自經營活動(主要為貿易應收款項)及源自融資活動,包括銀行存款、外匯交易及其他金融工具。本公司所面對現金及現金等價物產生之信貸風險有限,原因是對手方為獲國際信貸評級機構評定高信貸評級的銀行及金融機構,本公司對此認為信貸風險為低。

貿易應收款項

各業務單位在本集團既有關於客戶信貸風險管理的政策、程序及監控規限下,管理客戶信貸風險。所有超出若干信貸金額的客戶需要進行個別信貸評估。該等評估集中於客戶過往到期付款的記錄及現時的付款能力,並考慮客戶特有的資料以及客戶營運所在經濟環境的相關資料。貿易應收款項由發票日期起計30至90天內到期。結餘已逾期一個月以上的債務人須清償所有未償還結餘後方可再獲授任何信貸。一般而言,本集團不會要求客戶交出抵押品或其他信貸保證。

由於擁有大量客戶,本集團的信貸風險集中程度有限。

本集團並無提供任何會使本集團面臨信貸風險的擔保。

本集團按相當於全期預期信貸虧損的金額計量貿易應收款項的虧損撥備,有關金額採用撥備矩陣計算。由於本集團的過往信貸虧損經驗並無顯示不同客戶分部的虧損模式存在重大差別,故本集團並無進一步區分其不同客戶群之間按逾期狀況釐定的虧損撥備。

(c) Interest rate risk

The Group's lease liabilities and promissory notes bear interests at fixed interest rates and therefore are subject to fair value interest rate risk.

Except as stated above, the Group does not have other significant interest-bearing assets and liabilities at the end of reporting period, its income and operating cash flows are substantially independent of changes in market interest rates.

16. RETIREMENT BENEFIT SCHEMES

The Group operates a mandatory provident fund scheme (the “MPF Scheme”) under the Hong Kong Mandatory Provident Fund Schemes Ordinance for all qualifying employees in Hong Kong. The Group’s contributions to the MPF Scheme are calculated at 5% (2025: 5%) of the salaries and wages subject to a monthly maximum amount of HK\$1,500 (2025: HK\$1,500) per employee and vest fully with employees when contributed into the MPF Scheme.

As stipulated under the relevant rules and regulations in the PRC, the employees of a Group’s subsidiary established in the PRC is a member of a central pension scheme operated by the local municipal government. This subsidiary is required to contribute certain percentage of the employees’ basic salaries and wages to the central pension scheme to fund the retirement benefits. The local municipal government undertakes to assume the retirement benefits obligations of all existing and future retired employees of this subsidiary. The only obligation of this subsidiary with respect to the central pension scheme is to meet the required contributions under the scheme.

There was no forfeited contribution in respect of the defined contribution plan available at 31 March 2026 and 2025.

Obligation to pay LSP under Hong Kong Employment Ordinance (Chapter 57)

Hong Kong employees that have been employed continuously for at least five years are entitled to long service payments in accordance with the Hong Kong Employment Ordinance under certain circumstances. These circumstances include where an employee is dismissed for reasons other than serious misconduct or redundancy, that employee resigns at the age of 65 or above, or the employment contract is of fixed term and expires without renewal. The amount of LSP payable is determined with reference to the employee's final salary (capped at HK\$22,500) and the years of service, reduced by the amount of any accrued benefits derived from the Group's contributions to MPF scheme, with an overall cap of \$390,000 per employee. Currently, the Group does not have any separate funding arrangement in place to meet its LSP obligation.

In June 2022, the Government gazetted the Amendment Ordinance, which abolishes the use of the accrued benefits derived from employers' mandatory MPF contributions to offset the LSP. The Abolition will officially take effect on the Transition Date (i.e., 1 May 2025). Separately, the Government of the HKSAR is also expected to introduce a subsidy scheme to assist employers for a period of 25 years after the Transition Date on the LSP payable by employers up to a certain amount per employee per year.

Under the Amendment Ordinance, the Group's mandatory MPF contributions, plus/minus any positive/negative returns, after the Transition Date can continue to be applied to offset the pre-Transition Date LSP obligation but are not eligible to offset the post-Transition Date LSP obligation. On the other hand, the accrued benefits derived from the Group's voluntary contributions made pre-, on or post-transition can continue to be used to offset pre- and post-transition LSP. Furthermore, the LSP obligation before the Transition Date will be grandfathered and calculated based on the last monthly wages immediately preceding the Transition Date and the years of service up to that date.

2022年6月，政府刊憲修訂條例，廢除使用僱主強制性強積金供款所產生的累算權益來抵銷長期服務金。廢除將於過渡日期(即2025年5月1日)正式生效。此外，預期香港特別行政區政府亦將推出一項補貼計劃，以協助僱主在過渡日期後的25年間支付僱員長期服務金，每名僱員每年最高可獲得一定金額的補貼。

The Group's objectives when managing capital are to safeguard the Group's ability to continue as a going concern and to maximise the return to the shareholders through the optimisation of the debt and equity balance. The capital structure of the Group comprises all components of shareholders' equity.

The Group reviews the capital structure frequently by considering the cost of capital and the risks associated with each class of capital. The Group will balance its overall capital structure through the payment of dividends, new share issues and share buy-backs as well as the issue of new debts, redemption of existing debts or selling assets to reduce debts. No changes were made in the objectives, policies or processes for managing capital during the years ended 31 March 2026 and 2025.

The only externally imposed capital requirement for the Group is that to maintain its listing on the Stock Exchange it has to have a public float of at least 25% of the shares. Based on the information that is publicly available to the Company and within the knowledge of the directors, the Company has maintained a sufficient public float of at least 25% throughout the year ended 31 March 2026. (i) Share premium

Under the Companies Law of the Cayman Islands, the funds in the share premium account of the Company are distributable to the shareholders of the Company provided that immediately following the date on which the dividend is proposed to be distributed, the Company will be in a position to pay off its debts as they fall due in the ordinary course of business.

Share premium represents premium arising from the issue of shares at a price in excess of their par value per share and after deduction of capitalisation issue and issuance costs of shares.

(ii) Merger reserve

Merger reserve represents the difference between the aggregated amount of share capital, share premium and capital reserve of subsidiaries comprising the Group at the date on which Power Truth Holdings Limited (“**Power Truth**”), the then holding company of the subsidiaries comprising the Group, was acquired by the Company, over the nominal value of 2,000 shares issued by the Company pursuant to the group reorganisation on 10 November 2015.

Upon the disposal of a subsidiary as disclosed in note 36(a)(i) to the consolidated financial statements, the applicable part of the merger reserve was reclassified and credited to the Group’s accumulated losses.

(iii) Legal reserve

The Macao Commercial Code number 377 requires that companies incorporated in Macau should set aside a minimum of 25% of their respective profit after income tax to the legal reserve until the balance of the reserve reaches a level equivalent to 50% of their capital.
